**WHEREAS;** the exchanges between our countries add richness, diversity and the promise of global peace; and


**WHEREAS;** our friendship unites people of all ages and backgrounds and surmounts barriers of distance, culture, language and politics; and



**AN EXCEPTION TO DUNES CITY'S TWO-HOUR PARKING LIMIT —  
APPLICABLE TO OCEAN BOULEVARD FOR PARALLEL PARKING IN  
CONJUNCTION WITH RESIDENTIAL USE**

**WHEREAS.** Dunes City normally allows parking on city streets for a maximum of two hours out of 24 hours for no more than two consecutive days, and on-street parking exceeding this limit requires a Right-of-Way Use Permit, and;

**WHEREAS.** Ocean Boulevard is a one-way city street having a paved width of 10 to 12 feet and a right-of-way width of 60 feet, and;

**WHEREAS,** The Dunes City lakeside Right of Way on Ocean Blvd has historically been used by Ocean Blvd. residents for overflow guest parking, and;

**WHEREAS,** parallel parking would help to minimize the intrusion into the Riparian Area and Shoreland Zone and subsequent impacts on them, and;

**WHEREAS,** parallel parking on the lake side shoulder of the paved roadway, should not impede vehicle traffic.

**NOW THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF DUNES CITY, OREGON DOES HEREBY AUTHORIZE PARALLEL PARKING ON THE LAKE SIDE SHOULDER OF OCEAN BOULEVARD IN CONJUNCTION WITH OCEAN BLVD RESIDENT'S USE FOR THE PURPOSE OF OVERFLOW GUEST PARKING. THIS EXCEPTION TO THE DUNES CITY RIGHT OF WAY USE ORDINANCE DOES NOT INCLUDE CAMPERS, MOTOR HOMES, LIVEABLE VEHICLES OR CAMPING OF ANY KIND THE AFORESAID WHICH ARE STRICTLY PROHIBITED. UNINTERRUPTED USE OF THE OCEAN BLVD. RIGHT OF WAY FOR MORE THAN 72 HOURS WOULD REQUIRE A TEMPORARY RIGHT OF WAY USE PERMIT.**



WHEREAS, ORS 455.210 (3) allows municipalities to adopt "reasonable fees" to "provide for the administration and enforcement" of the building code program.

WHEREAS, if the Dunes City assesses a charge on all its permits, whether or not they relate to the building code program, then it will not need to be incorporated into its fee schedule. If Dunes City assesses a charge **only** for actions related to the building inspection program then it must be figured into its building permit fee schedule.

NOW THEREFORE BE IT RESOLVED that the City of Dunes City will apply the greater of a 7% or \$25.00 surcharge to all permits and it will be called the **building Surcharge**.

**A RESOLUTION ADOPTING DUNES CITY'S REPRESENTATION IN THE  
CITY OF FLORENCE'S MULTI-JURISDICTIONAL NATURAL HAZARDS MITIGATION PLAN**

**WHEREAS**, the City of Dunes City is vulnerable to the human and economic costs of natural, technological and societal disasters, and

**WHEREAS**, the City Council of Dunes City recognizes the importance of reducing or eliminating those vulnerabilities for the overall good and welfare of the community, and

**WHEREAS**, the City of Dunes City has participated in the development of the City of Florence's Multi-Jurisdictional Natural Hazards Mitigation Plan, which has established a comprehensive, coordinated planning process to eliminate or minimize these vulnerabilities, and

**WHEREAS**, the City of Dunes City's representatives and staff have identified natural hazard risks and prioritized a number of proposed actions and programs needed to mitigate the vulnerabilities of Dunes City to the impacts of future disasters, and

**WHEREAS**, these proposed projects and programs have been incorporated into the City of Florence's Multi-Jurisdictional Natural Hazard Mitigation Plan that has been prepared and promulgated for consideration and implementation by the cities of Florence and Dunes City; **NOW THEREFORE**

**THE COMMON COUNCIL OF THE CITY OF DUNES CITY RESOLVES AS FOLLOWS:**

**Section 1.** The Common Council of the City of Dunes City hereby accepts and approves of its section of the City of Florence's Multi-Jurisdictional Natural Hazards Mitigation Plan as a reasonable process to identify and plan for potential hazards in Dunes City,


**Section 2.** The agency personnel of the City of Dunes City are requested and instructed to pursue available funding opportunities for implementation of the actions and proposals designated therein,

**Section 3.** The City of Dunes City will, upon receipt of such funding or other necessary resources, seek to implement the mitigation proposals identified by the Jurisdiction's Hazard Mitigation Planning Committee, and

**Section 4.** The City of Dunes City will continue to participate in the updating and expansion of the City of Florence's Multi-Jurisdictional Natural Hazards Mitigation Plan in the years ahead, and

**Section 5.** The City of Dunes City will further seek to encourage the businesses, industries and community groups operating within and/or for the benefit of the City of Dunes City to also participate in the updating and expansion of the City of Florence's Multi-Jurisdictional Natural Hazards Mitigation Plan in the years ahead.

**Resolution No 2-12-09 (B)**

**A RESOLUTION URGING ENACTMENT OF COMPREHENSIVE NATIONAL  
HEALTHCARE REFORM AND INSURING HONEST, FAIR HEALTHCARE  
REFORM DEBATE**

**WHEREAS**, every citizen and family of Dune City, the State of Oregon, and the United States, will benefit from affordable, quality healthcare, and believing that disruptive healthcare cost burdens on local economies and governments would be reduced thereby, and

**WHEREAS**, over 80 million Americans have major healthcare insurance problems, including 42 million Americans currently uninsured, and over 40 million Americans nationwide currently underinsured; that the burden on small employers of providing employee health insurance is becoming increasingly difficult and prohibitatively expensive, which impacts their ability to remain competitive; and

**WHEREAS**, that such matters as healthcare affordability and access ultimately are community issues with local importance and long-term impacts that strain city and local government budgets in diverse ways, such as public safety and school health issues; and

**WHEREAS**, Americans spend more for health care as a percentage of national *Gross Domestic Product* than any other industrially developed nation; and that America, unlike all or almost all other industrially developed nations, has a fragmented health care delivery system; and that, as a matter of common sense, such fragmentation contributes to higher costs and inefficiencies; and

**WHEREAS**, those insured may still experience high medical debt, and that such medical costs are a frequent cause of filing personal bankruptcy for those that are insured, and

**WHEREAS**, numerous reports show private insurance systems have higher levels of administrative costs compared to public Single-Payer systems such as Medicare, and

**WHEREAS**, the United States has created various "Single-Payer-type" medical systems, including Medicare, and that bills have been filed in Congress seeking "Single-Payer-type" comprehensive health system reform, including HR 676, which currently has at least 86 sponsors in the House of Representatives, and

**WHEREAS**, as of the date of this resolution, it appears a majority of American physicians believe that Single-Payer type systems offer the best method of securing affordable health care, and


**WHEREAS**, such Single-Payer-type systems have been unanimously endorsed by the **U.S. Conference of Mayors**, and **further endorsed** by various state legislative bodies, including the New Hampshire House of Representatives and the Kentucky House of Representatives, **and further endorsed** by various medical professional associations including the National Medical Association, American Medical Women's Association, American Medical Student Association (AMSA), American Association of Community Psychiatrists, American Nurses Association, California Nurses Association/National Nurses Organizing Committee, and the American Public Health Association,

**WHEREAS**, Citizens of Dunes City, Oregon and the United States will benefit from an honest and full debate on alternative health reform proposals only if such debate fairly includes the advantages associated with Single-Payer-type or expanded Medicare-for-all, such as HR 676;


**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF DUNES CITY, OREGON:**

**SECTION 1.** That the Dunes City Council, in order to ensure that all Americans, like citizens of every other developed industrialized nation in the world, will have access to higher quality and cost-effective health-care, urges the Oregon Congressional Delegation and the United States Congress to enact comprehensive health system reform after insuring an honest, full and fair debate of the options, and that such debate must include Single-Payer-type systems and expansion of a Medicare-for-all system, and their respective advantages,

**SECTION 2.** Dunes City Council directs a copy of this resolution be sent to our primary county newspapers, radio and television stations, and our Federal Representatives for their due consideration and enactment.

**RESOLUTION CERTIFYING DUNES CITY PROVIDES FOUR  
MUNICIPAL SERVICES ENUMERATED IN SECTION 1, ORS 221.760**

WHEREAS, ORS 221.760 provides as follows:

Section 1 The officer responsible for disbursing funds to cities under ORS 323.455, 366.785 to 366.820 and 471.805 shall, in the case of a city located within a county having more than 100,000 inhabitants according to the most recent federal decennial census, disburse such funds only if the city provides four or more of the following services:

(1) Police protection; (2) Fire protection; (3) Street construction, maintenance, and lighting; (4) Sanitary sewer; (5) Storm sewers; (6) Planning, zoning, and subdivision control; (7) One or more utility services

WHEREAS, City officials recognize the desirability of assisting the state officer responsible for determining the eligibility of cities to receive such funds in accordance with ORS 221.760.

NOW THEREFORE BE IT RESOLVED that the City of Dunes City hereby certifies that it provides the following four municipal services enumerated in Section 1, ORS 221.760:

- (1) Fire protection;
- (2) Street construction, maintenance, & lighting;
- (3) Storm sewers
- (4) Planning, zoning, and subdivision control.





**A RESOLUTION GRANTING THE ROAD COMMISSION THE AUTHORITY TO REVIEW AND AUTHORIZE THE PLACEMENT OF PUBLIC UTILITY FACILITIES WITHIN THE CITIES RIGHT OF WAY.**

**WHEREAS. DCC 32.47(E) Road Commission Duties states.**

It shall consider citizen requests for temporary use of City street rights-of-way, removal of trees and vegetation from street rights-of-way and make recommendations thereon to the City Council. (Ord. 149, passed 8-8-96)". And

**WHEREAS. DCC 32.48 Road Commission powers and limitations states.**

Neither the Road Commission, as a whole, nor any member or members individually or collectively shall exercise authority to bind the City, its officers, or its agents to any financial commitment or obligation (except as specifically directed or authorized by the City Council). The Road Commission has only those powers and duties as are now or hereafter granted and imposed on it by the City Charter, ordinances, and directives of the City Council. All actions of the Road Commission shall be deemed advisory to the Mayor and City Council and shall have no legislative or judicial effect unless and until formally adopted by the City Council. (Ord. 149, passed 8-8-96). And

**WHEREAS,** The Dunes City Council recognizes the need to create a more efficient permitting process for routine facilities placement in the City's Right of Way. And

**WHEREAS.** The council recognizes that the placement of public utilities in the City Right of Way do not constitute a permanent obstructions to future Right of Way options. And

**WHEREAS,** Currently the accompanying excavation permits within the cities right of way are treated as a type 1 procedures with the authority resting in the city recorders office. DCC 90.11(A). And

**WHEREAS.** The Dunes City Council continues to have the authority to revoke all granted Temporary Right of Way uses.

**NOW THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF DUNES CITY, OREGON DOES HEREBY GRANT THE ROAD COMMISSION THE AUTHORITY TO REVIEW AND AUTHORIZE THE PLACEMENT OF PUBLIC UTILITY FACILITIES WITHIN THE CITIES RIGHT OF WAY.**
