## **REQUIRED INSPECTIONS**

## MANUFACTURERS INSTALLATION INSTRUCIONS MUST BE AT THE JOB SITE.

Call for the following inspections when the work is completed, but prior to covering up work which is to be inspected. 24 hour inspection notice is required.

- 1. <u>FIRST INSPECTION:</u> Set-Backs, Foundation (Strip Footings).
- 2. <u>SECOND INSPECTION:</u> Blocking, Water, Sewer, Electrical Service, Mechanical Cross-Over, Vapor Barriers, Hold Downs if Required. BEFORE SKIRTING.
- 3. <u>FINAL INSPECTION:</u> Skirting, Storm Water Drainage, Landings and Steps, Woodstove, Accessory Structures. BEFORE OCCUPANCY.

Note: Water service and building sewer under test and BEFORE COVER shall be done during one of the three inspections.
