A RESOLUTION APPROVING AN APPLICATION TO NAME OR RENAME A ROAD AND ESTABLISHING FEES ASSOCIATED THEREWITH IN ACCORDANCE WITH ORS 227.120 AND THE PROVISIONS OF DUNES CITY'S MASTER ROAD PLAN.

WHEREAS, ORS 227.120 provides the procedure for renaming roadways within the State of Oregon; and

WHEREAS, Section 3.6 of the Dunes City Master Road Plan, adopted by the City Council on April 10, 2014, sets out the process and requirements of obtaining or renaming a roadway in Dunes City and;

WHEREAS, Section 3.6(3) of said Master Road Plan establishes the payment of a Non-Refundable Fee to accompany an application to change the name of a street or roadway in Dunes City; and


WHEREAS, heretofore, the Dunes City Council has never adopted an application form to change the name of a street or roadway in Dunes City, nor has the Council ever set the fee for processing the same;

NOW, THEREFORE, the City of Dunes City hereby resolves that the attached form entitled "Application to Name or Rename a Road" be, and hereby is, adopted for use; and


BE IT FURTHER RESOLVED that the City of Dunes City hereby sets the filing fee for an application to Name or Rename a Road to \$600.00, to be paid at the time of filing the application.

NOTE: Additional signatures may be provided on reverse. Naming or renaming a road requires a public hearing. A fee of \$600 is required for processing, payment must accompany the application.

The naming or renaming of this road may result in a change of address for residents who enter their driveways from this road.

Please attach a map showing the location of the road to be named or renamed.

City of Dunes City Name Standards

The proposed name should comply with the following standards:

- (a) Name limited to maximum of 20 characters.
- (b) No duplication with other existing road names.
- (c) No similar sounding or confusing names.
- (d) No names with post-directional language (i.e., “North”, “South”).
- (e) No names with punctuation.
- (f) No names that are alpha/numeric (i.e., a combination of letters and numbers).
- (g) No names that contain a road type within the road name (such as “Loop or Lane”).
- (h) Roads shall not contain an abbreviated MT (mount/mountain) or ST (saint) without another word following (ex: Shasta MT Rd is not acceptable, MT Shasta Rd. is acceptable).
- (i) There must be a valid road type following the roan name (i.e., “Road”, “Street”, “Drive”, “Lane”, etc.).
- (j) “Trail” is acceptable as part of a road name but not as a road type (ex: Deer Trail is not acceptable, Deer Trail Rd is acceptable).
