1. CALL TO ORDER

Mayor Rebecca Ruede called the September 13th Special Session of the Dunes City Council to order at 3:00 pm.

2. ROLL CALL

4. APPROVAL OF THE AGENDA

Before requesting a motion to approve the Agenda, Mayor Ruede suggested making Agenda Item No. 8 (Old Business) Agenda Item No. 6, following Agenda Item No. 5 (Citizen Input). There were no objections.

Council President Sanders made a motion to approve the Agenda as amended. Councilor Wells seconded the motion. The motion passed by unanimous vote.

A. Approval of Engagement Letter with Auditors
