BEING PREPARED

Dunes City has requested that West Lane Emergency Operations Group (WLEOG) make an informational presentation to the City Council. The purpose of the presentation scheduled for July 21 at 6:00 pm, is to fully describe the functions of the organization, the history behind it, a debrief on the events of the March 2011 Tsunami Warning event, where the organization is heading, the projects that are underway, and what the WLEOG sees in the future.

Siuslaw Valley Fire and Rescue Chief John Buchanan, Western Lane Ambulance District Director Henry Hanf, and Florence Police Chief Maurice Sanders will make that presentation along with Dunes City Recorder, Fred Hilden. This will be an opportunity for the Dunes City Council to ask questions of some of the leadership team of the WLEOG. It will also serve as an educational meeting for members of the community to supplement the disaster preparedness training and information that has already occurred in Dunes City. Finally, members of the Council and community may have interest into the actions taken regarding the recent Tsunami Warning Event from the emergency management perspective. We hope that all in Dunes City will find this of benefit! W

Dunes City as Mayor this year. Prior to becoming Mayor, I was Chair of the Communication & Education Committee and the Revenue Committee. These committee chairs have been reassigned to Dick Anderson and Ed Scarberry, respectively. The C & E Committee has already begun to discuss rejuvenating the Dunes City website and newsletter with creative ways that will improve communication. You will note that the newsletter insert has been re-designed with the Directory information on it. The thought was that it could be removed and used as a reference piece in your home. We will also add a flora and fauna focus that will feature Dunes City nature and wildlife.

The website will feature a current events or "hot topic" category that citizens can access for timely information on the issues before the council. The goal is to make the website more user-friendly which we hope will inspire more volunteers to get involved.

Enough about business, here is a bit of a biography that maybe some didn't know. I am employed by US Bank in Florence as Branch Manager Assistant Vice President. I really enjoy working as a volunteer in public service. I believe if you think you can contribute to society then you should. It's your civic duty.

Council President Jamie Mills ~ My husband Robin and I traveled the Oregon coast on our honeymoon in 1996.



It was during that trip that we discovered the Florence area and made an offer on a Tsiltcoos Heights home in Dunes City. We spent about half of our time in Dunes City and the rest of the time on the family angus beef ranch in Nevada. On another visit in 2003, we discovered a piece of property closer to Siltcoos Lake, made an offer, and purchased it. It is on this lot that our home sits today. We have been asked to reveal something about ourselves in this article - some little quirk that we have. Well, I'm addicted to Egg McMuffins. There, I said it. It is all out in the open now. When you see me barreling toward town at ten in the morning, its because I'm trying to beat the end of breakfast deadline at McDonalds. Now you know.

One of my goals as City Councilor is to update the Code of Ordinances. The Code has not been codified (meaning brought current to include all ordinances that have been passed) since 1999. This makes it very difficult for staff, council members and residents to accurately understand what our laws actually say. This will be tedious, and often mind-numbing work, but it must be done as soon as possible.

Another project I will be pursuing is to secure the future water supply for the residents of Dunes City. There are numerous options available to achieve this goal. The

success will be in properly researching each option and then determining which one, or combination of options, might be best suited for Dunes City and its citizens. In the meantime, I think it is unwise to abandon any water right held by Dunes City until we are certain of the consequences of giving up those rights.

Much work has been done in preparing our community for a disaster. I would like to see that work continue and

expand so that we have an organized and localized emergency plan and information dissemination system so our residents and visitors will know exactly what to do and where to find help in the event of an emergency.

A portion of the tax dollars Dunes City receives comes from people who visit our community. These economic activities are usually directly related to either Woahink or Siltcoos Lakes, or the sand dunes. While we don't have much control over the sand dunes, we can enhance the recreational opportunities on Woahink and Siltcoos by participating in programs, such as fish-stocking, and we can more actively promote tourism.

Aquatic weeds are having a devastating affect on the water quality, fish habitat, and recreational opportunities in both Woahink and Siltcoos Lakes. The decomposition of these weeds and other plant materials has been scientifically proven to play a role in increasing the nitrates and phosphorous levels in the lake that contribute to algal blooms. While many say the problem is too big to tackle, I can't help but think that sitting back and doing nothing is just not a viable, or intelligent, option. The Water Quality Committee already has a long list of projects it wishes to pursue this year, but my hope is to add the development of an aquatic weed management plan – one that specifically addresses what Dunes City residents can voluntarily do to help control aquatic weeds in the lakes.

No matter what actions the City Council chooses to take, all must be weighed as to cost versus benefit. While we might like to protect everyone from everything, it just isn't realistic. It is my hope that future Council decisions will be based on sound judgment and common sense.

Councilor Richard Koehler ~ We are special and I am proud to help here. Without paying others to provide ser-



vices, we are dependant on one another and on nature. It is impossible to compare Dunes City's particular qualities to other towns. While I was Water Quality and Communications and Education Chair I discovered creative ways to maintain our natural area and independence.

I am Richard Koehler, now your Parks and Recreation Commission Chair. As chair I will help other citizens fulfill our city's Comprehensive Plan goals by collaborating with County, State and Federal agencies to secure Dunes City as the place for recreation and touring our great rural water wonderland. I advocate low-impact and low-cost community betterment hoping that common sense and facts educate those who concern themselves with the future. Keeping transparency at the fore, I hope to be a part of a solution as I continue work as the dunescity.com webmaster.

Beside my duties as a Dunes City Councilor, I am chairman of the Siuslaw Area Partnership to Prevent Substance Abuse, working to assist young and old alike in making healthy choices through awareness. For the greatest part of my life I have been self employed as a circulatory therapist, radio producer, builder, designer and investor. My life experience has proven valuable in supporting Dunes City's independent, rural,

course. I consult local groups to promote effective website design, tolerant public policy and informed participation. In all I do I ask; How do messes start and how can I stop them before they start? Participation with the City's septic maintenance, nuisance, and business license ordinances as well as the recent 'Are you Ready' disaster preparedness programs has enabled our citizens to maintain a community free of bureaucracy.

Answers to how we can all be part of the solution are found in the newsletters I previously edited, website I oversee and the previous educational City events I helped produce. Wouldn't it be better that each of us do a small part now than pay for poor planning and a wasteful bureaucracy later?

Spring Cleaning Tips

Spring is finally here and everyone is eager to begin tackling their long list of outdoor chores in preparation for the summer season. Our biggest concern in Dunes City is clean drinking water. There are many things we cannot control, but there are many other things we can. Remember that all storm water (rain) runoff eventually winds up in the lakes. That means anything you put in your yard ends up in our drinking water. Please don't use anything toxic or with phosphorus in it. Phosphorus contributes to algae blooms when the lake warms up and so do animal droppings.

We are careful not to feed the wildlife for two reasons; geese ~ so they won't stay in the area instead of migrating (more poop in the lakes), deer and raccoons because people food is not good for them and contains more phosphorus. I am always surprised at the many piles of dog poop beside the road. This adds both nutrients and bacteria to our drinking water (both are bad). Also, it is best to use the car wash in town if possible, since the chemicals in it are harmful. Any expired medicines can be disposed of at the hospital. Please don't flush them into our water: the septic system cannot remove them.

Any citizen who would like to attend a Road Commission meeting can come and join us every third Monday of the month at 6:30 pm at Dunes City Hall.




Volunteers with a boat!!!


also enjoy scuba diving "for food," arrowhead hunting and sheep horn hunting in Eastern Oregon. Mining for gold has also been a lot of fun.
