1. CALL TO ORDER

The Special Session of the Planning Commission was called to order by Chairman George Burke at 3:00 pm.

Commissioner Norman Martin made a motion to approve the Agenda. Commissioner Darlene Beckman seconded the motion. The motion passed by unanimous vote.

9. Unfinished / Old Business

A. Continue Review of Chapter 154.

Commissioners agreed to make the following changes to the proposed language:

Section 154.05 Re-vegetation of Cleared Areas, paragraph A-2, change language to read, "A re-vegetation plan prepared by an Oregon registered landscape architect and approved by the Planning Commission."

In paragraph B:

- 1. Change language to read, "In reviewing a re-vegetation plan required in paragraph (A) of this section, the Planning Commission will consider the following criteria:"
- 2. Insert "and" at the end of criterion (1),
- 3. Replace criterion number 2 with, "Applicable provisions of the Dunes City Comprehensive Plan."
- 4. Delete criterion number 3 entirely.

Section 154.06 Vegetation Cutting and Removal in Public Rights-of-Way, change paragraph A to read, "No tree or vegetation shall be cut or removed from any public right-of-way without approval of the Road Commission."

Section 154.07 Violations

- 1. Change paragraph A to read, "Violations of this Chapter are subject to enforcement under Chapter 36 of Dunes City Code."
- 2. Delete the remaining content entirely.

Section 154.99 Penalty is to be entirely deleted.

Chairman Burke suggested that the Commission schedule a Special Session to meet with the City Engineer to discuss soil erosion and storm water management plans. It was agreed by all that the Special Session would be tentatively scheduled for Tuesday, August 27, 2013 at 2:00 pm, depending upon City Engineer's availability.
