A RESOLUTION OF SUPPORT FOR DUNES CITY'S APPLICATION FOR AND AWARD FOR A TRANSPORTATION AND GROWTH MANAGEMENT (TGM) GRANT TO LOCAL GOVERNMENTS FOR 2013

WHEREAS, the Dunes City Council wants a process for mapping, evaluating and developing a future plan for roads within the Urban Growth Boundary (UGB); and

WHEREAS, a complete and revised up-to-date Master Road Plan is necessary to meet the needs as established by the City of Dunes City Comprehensive Plan; and

WHEREAS, the City of Dunes City Comprehensive Plan Section F states that the "City will develop a master transportation plan that includes an inventory of existing streets, bike and pedestrian ways and their condition, prioritizes needed improvement, and estimated costs."; and

WHEREAS, the city needs improvement upon its Pavement Condition Index to meet the requirements of the City of Dunes City Comprehensive Plan Section F; and

WHEREAS, the city needs a Sign Inventory to meet the requirements of the City of Dunes City Comprehensive Plan Section F; and

WHEREAS, the city needs an assessment for bike and pedestrian ways in the City to meet the requirements of the City of Dunes City Comprehensive Plan Section F; and

WHEREAS, the City of Dunes City does not have the funds needed to meet these requirements without grant funding and that the City of Dunes City meets the definition of "distressed" by the Oregon Business Development Department and as such may request a partial match waiver for such grant funding; and

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF DUNES CITY, OREGON, DOES HEREBY SUPPORT SUCH GRANT APPLICATION AND REQUESTS OREGON'S DEPARTMENT OF TRANSPORTATION (ODOT) TO APPROVE ALL REQUESTED FUNDING AS OUTLINED IN THE TGM GRANT APPLICATION TO ALLOW THE CITY TO MEET ALL REQUIREMENTS OF THE CITY OF DUNES CITY'S COMPREHENSIVE PLAN AS IT RELATES TO TRANSPORTATION PLANS AND INCLUSIVE INVENTORIES, CONDITIONS, AND PRIORITIZATION OF NEEDED IMPROVEMENTS.
