Mr. M.E. Miller from the Oregon Insurance Rating Bureau was introduced by Mayor LaForge. Mr. Miller talked on the purpose of his company he represents re: fire insurance rates in which cities are graded from 1-10 with #10 representing the lowest rate. Dunes City is classed as #8. With a water system, Dunes City possible would be rated a #7. On a house valuation set at \$7,500., reduction of 15.15 % on fire insurance from a grade of 8 to a grade of 7 or on a house of same valuation there would be a reduction of 27.41% from a grade of 8 to a grade of 6. It was learned from Mr. Miller that the City Council would have to request for a reclassification of a city which would take to 6-8 months to reclassify the rate after they received the request.

Mr. W.F. Perley then introduced Leland K. Haldorson, County Supervisor, and Kenneth K. Keudell, Engineer, from the Farmers Home Administration.

Mr. Keudell reported that FHA would not be able to give any grant to Dunes

City on the water system due to the fact that Dunes City has fire protection between though FHA could assist in purchasing bonds on the basis of 40 years with the current rate of interest of 5%. He explained the difficulties of private agencies buying bonds at this time at a high rate of interest possible at the rate of  $66-6\frac{1}{2}$ %. Three possible sources of aid could come from HUD, Office of Economical Development or FHA. The government could buy the bonds at the earlist time of 2 years as Dunes City would not qualify for any assistance from FHA buying of bonds for this next budget year due to the time element.

It was further learned from FHA that FHA on building loans will not come into rual housing but can if with a water system. Persons attending the

There was also much discussion on the water system. Persons attending the special meeting were concerned about the overflow of Woahink into Siltcoos Lake if water was to be taken from Woahink Lake. Mr. Perley explained that if Woahink Lake received no water from any source for one year and water was being pumped out at the maxium rate, the lake would lower only 3 inches for that one year period.

A motion was made by Martin Christemsen to sign the annexation of Alerwood Estates, First Addition. It was seconded by Philip Himmel. Motion carried.

#### PUBLIC HEARING

#### Westlake Sportsman's Club Tuesday, May 27, 1969

Mayor Bernie LaForge opened the hearing with a brief summary of why the Dunes City Council determined a need for a water system. He explained that the Department of Housing and Urban Development was allocating grants to small cities, helping them to investigate the possibilty of water system installation. Mayor LaForge also pointed out that until the proposed water system is accepted, the city will not be indebted for the cost of engineering.

Among officials present at the meeting were County Sanitarian John Stoner, Harold Merryman, district sanitary engineer for the State Board of Health, and Roy Burns, representative
of the State Sanitary authority working in Lane County. All of
the officials agreed that a water system of some kind should be
installed in Dunes City, owing to contamination, bad existing
wells, and insufficient treatment of water already being drawn
out of Woahink Lake.

The Dunes City council recommends a tax of \$1.60 per \$1,000 of true cash value, which will decrease as Duns City population increases to absorb the fixed tax base of \$9,650.

W.F. Ferley, consulting engineer from portland, stated that the proposed water system was split into two parts to allow for it to be installed in two phases serving the area needing it most first. He said much of the cost was due to the area being spread over such a large area, (7.5 square miles).

total cost of putting a pumping station on Woahink Lake, setting a water tower on some of the highest ground in the city, and putting in the mai/s to serve the present residential areas, 398 home equivelents was estimated at \$724,776.50. To go to the sand dunes for water is estimated would cost an additional \$150,000. The higher cost is due to the necessity to remove the iron from the water through a precipitation process, the drilling of test wells and longer transmission lines.

Some of those present at the hearing were concerned that boating would have to be curtailed on the lake if it becomes the source of water for the city. This fear was quelled, however, it was noted that efforts would have to be made to insure against the disposal of human waste from boats using the lake. Bob Read was also concerned that if boats were curtailed from the lake that the tax base valuation would be higher if recreation were taken away.

Phil Himmel stated that it would be benificial to the people of Dunes City to file a water rights claim on Woahink Lake to keep others from controlling the use of water from the lake.

Considerable discussion at the meeting was also devoted to the different financing possibilities. Some of those present seemed to favor establishment of a water district such as the Heceta Water District.

It was pointed out by John Stoner that if the community was under the jurisdiction of Lane County, the county would most likely be more strict of lot sizes, and water use regulations.

A show of hands rewealed that those who favored a water system of some form were 15 to 7 over those who wanted no system at all. A later question regarding the proposed water sys-

tem tallied 6 votes of 35 present, in favor.

Bob Read proposed cutting the plans back to provide water for the Westlake residents at this time, the area generally agreed to have the greatest need. He argued that other areas could be added as residents feel the need. The "minimum" system such as he was proposing would include a pumping station, trunkline from the intake to Westlake, a reservior and filtration system, and would serve 141 resident connections. It would cut the cost at this time an estimated

Order of bussiness was Bill 1600 Chaper 634 which states in brief that a city must provide four or more services out of seven requirements. This affects only four counties with population of 100.000 and over: lane. Marion. Multnohmah and Clackamas.

Dunes City provides only three services: Police protection; Planning, zoning and sub-division control; Street construction, maintanence and lightening. After much discussion, storm sewers the only service that possibly could be obtained for the fourth service that is required for Dunes City.

A motion was made by Wm. F. Riesenhuber and seconded by John Sauer for City Attorney Sidney Nicholson to get a ruling from the State Highway Department in regard if the State Highway funds may be used for other purposes besides what the funds are planned for at this time. If letter is back in time, it will be read at the next regular council meeting.
