#### MINUTES OF THE DUNES CITY COUNCIL

#### REGULAR MEETING

#### JANUARY 14, 1982

#### I. CALL TO ORDER AND ROLL CALL

The regular meeting of the Dunes City Council was called to order by Mayor Petersdorf at 7:30 P.M. on the 14th day of January, 1982.

II. BILLS AGAINST THE CITY

The bills totaled 2,818,25.

- ION E. FILLMAN moved to pay the bills against the City. E. PASSENGER seconded and the motion carried.
  - III. RECEIPTS OF SESSION 3,948.49
  - IV. APPROVAL OF MINUTES DECEMBER 10, 1981

ACTION E. PASSENGER moved that the minutes of December 10, 1981 be approved. J. BAUMEISTER seconded and the motion carried.

- V. CITIZENS INPUT ON UNSCHEDULED ITEMS None
- VI. ANNOUNCEMENTS AND CORRESPONDENCE

HWY 101 INTERSECTION - D. Stinger gave a brief report on the correspondence with Mr. Alfred Shirley, State Hwy Engineer. The City sent a letter to Mr. Shirley reminding him that that State was to do a survey of that intersection in October. The return letter from Mr. Shirley stated that the survey was scheduled to be done the week of January 11. 1982.

# VII. REPORTS

RETAINING WALL :OCEAN BLVD. - The Committee that was to look into the retaining wall of Ocean Blvd. was J. BAUMEISTER, E. FILLMAN, and J. FREELAND. J. BAUMEISTER stated that the retaining wall was on City property, however, it was done in good taste. It is keeping the dirt from washing away. There is also water and electricity that goes down to this property from Bob Jackson's house. It is used by people in the summer.

Council discussed the fact that even though it looks nice and

has improved the looks of the City, it is still on City property and something needs to be done so that others don't follow suit.

Several alternatives were discussed such as a permit to allow Mr. Jackson to use this property but also stating that since it is City property others may also use it. Also the possiblitie of making this piece of property a park and name it "Bob Jackson's Park" was discussed.

B. STOCKING suggested that the committee go back and make a more complete site review of the property. Possibly make sketches of the project or take pictures. If there is going to be action taken on this there should be something for the files. Especially if other property owners in the area are going to be notified of what is going to take place.

Council discussed this further and decided that the committee would submitt another report to the Council at the next meeting. Also the City would publicized a Public Hearing so others in the area could give input.

ECONOMIC. DIVERSIFICATION COMMITTEE- E. FILLMAN stated that he attended this meeting last month and that in the two hours he was there all that was decided was that they would have another meeting on January 19 and have a representative from each governmental body attend and bring some ideas back. They are looking for ideas that will help to improve the economy such as small businesses that will employ about 10 people, etc.

Council discussed several ideas that FILLMAN could take back to the meeting of January 19. BAUMEISTER suggested the possibilitie of a radio station in Florence. E. PASSENGER stated that more things could go up the river further. Also the fact that the County has everyones hands tied because of zoning up the river and North of Florence, is so strict, was discussed.

POLICE REPORT - N. PIONEER COMPLAINT - E. PASSENGER stated that she drove down N. Pioneer several times and did not find anywhere that garbage was being thrown in the street. There was some discussion on whether she looked at the right street. It was decided that the street that was the problem was N. Pioneer between Clear Lake and Darlings Loop. She stated that she did drive down that road and saw nothing of garbage there but did see that people are parking on the street and it makes it hard to get through. There is no way that a fire truck could go through there. Council discussed what kind of street N. Pioneer is and whether the City could enforce not parking on the street. It was decided that this would be checked into further.

BUS SHELTER - D. STINGER gave a brief report on the bus shelter on Clear Lake Rd. and Erhart. She stated that the shelter is built but not painted yet. They have spent about 125.00 so far but do need some roofing and possibly more paint. They will be within the \$150.00 limit.

CCI- J. BAUMEISTER gave a short report on the CCI action with the Comp Plan update. They have scheduled a meeting for January 28 at 6:30. He stated that he had a committee of 7 people and will possibly have 2 more to add. He would like to have the City Recorder call these people the day before the meeting to remind them . He also stated that he talked to Gary Darnell of LCDC and he or one of his staff will also attend this meeting. It was started that the City Council and the Planning Commission should also try to attend this meeting. It was also stated that this meeting should be publicized and also put in the announcements on the Siuslaw News.

HEARING PGE - GERBER- A notice of a hearing in front of the Public Utility Commissioner. P G E has approached the Public Utility Commissoner and asked that a rule and regulation be enacted permitting to charge users who request to have overhead wires put underground. Otherwise those expenses are charged throughout the system. All users pay for this rather than just the user that requested it.

911- Gerber stated that the City did send a letter to the Senate stating that they did not agree with this surcharged because this area has had 911 service for quite some time. However they did pass it. What is going to happen is that the 911 3% surtax for Emergency Telephone service has been passed and the State is collecting that money and it will be distributed to municipallities that have agreed to participate. This was discussed by Council and decided that Dunes City should apply for this surtax since it is going to be given out anyway and that Dunes City should participate in this program.

CABLE TV - GERBER stated that there will be a meeting with the Cable TV on January 20, 7:00 at Florence City Hall. He stated that probably the City will have to hold an extra meeting this month to act on a mutual agreement. He will have a draft of such an agreement typed up in a few days for all of the Council to look at.

PLANNING COMMISSION CHAIRMAN - Mayor Petersdorf introduced the New Planning Commission Chairman Bob Camera. Mr. Camera was in the audience and gave a brief update on what is going on with the Planning Commission and what he would like to see done in the new year.

Passenger mentioned that the City Council had before them a recommendation to reappoint, J. Smith to the Planning Commission because her term had ended. She stated that this needed to be tabled until the dates on the terms could be checked over because there was an error in the term dates listed on the City Directory. One of the 1981 terms should be 1982. D. Stinger stated that she would check on these dates.

ORDINANCE #72 - Streets-

ACTION E. FILLMAN moved that the Council have the second reading of Ordinance #72 by short title. J. FREELAND seconded and the motion carried.

Gerber gave the second reading of the Ordinance #72 by short title.

ACTION E. PASSENGER moved that the Council accept the second reading of Ordinance #72. E. FILLMAN seconded.

Ayes: Fillman, Passenger, Freeland, Schmale, Baumeister

The motion carried unanimously.

OCCUPANCY PERMIT - Council did not feel that they had all the information needed to consider this. It was tabled.

ORDINANCE 51-12-10 - GERBER stated that this Ordinance was drafted to include the recovering of attorney fees in the Nuisance Ordinance #51.

ACTION E. PASSENGER moved to accept the first reading of Ordinance #51-1210 by short title. SCHMALE seconded and the motion carried.

GERBER gave the 1st reading:

THIS IS AN ORDINANCE AMENDING ORDINANCE #51 TO ENTITLE THE CITY TO RECOVER ATTORNEY FEES AGAINST PERPETRATORS OR NUISANCES AND OWNERS OF PROPERTY UPON WHICH NUISANCES ARE SITUATED.

ACTION E. PASSENGER moved to accept the first reading of Ordinance #51-1210 by short title. Schmale seconded.

AYES: FILLMAN, FREELAND, PASSENGER, SCHMALE, BAUMEISTER

The motion carried unanimously.

E. PASSENGER brought up the Lemke Abatement and that she wanted to know what is going on over at that property as far as the planting to stabilize the hillside. B. STOCKING stated that she call Ternyik and was told that Wednesday they were over there planting the beach grass.

#### IX. NEW BUSINESS

PUD AGREEMENT - GERBER gave a brief on this agreement presented to the City by Marilyn Adkins of Central Lincoln PUD. This agreement would give the City the power to give input on decisions with the Central Lincoln PUD. Council discussed this at some length.

- ACTION E. PASSENGER moved that the City enter into this agreement with the PUD. R. SCHMALE seconded and the motion carried.
  - E. FILLMAN brought up the fact that he personally has had some

problems with the fact that he lives in Dunes City and his mail comes through Westlake Post Office. He proposed that the City look into getting the Westlake Post Office changed to the Dunes City Post Office. He realized this was tried several years ago and residents did not want this however, Dunes City is now on National Maps and Westlake is not. This was discussed and found that possbily Attorney Gerber could draft a petition to be circulated throughout Westlake. Also the City would have to find out through the Post Master General if this could be done. It was to be looked into further.



FEBRUARY 11, 1982

## I. CALL TO ORDER AND ROLL CALL

The regular meeting of the Dunes City Council was called to order by Mayor Petersdorf at 7:30 P.M. on the 11th day of February, 1982.

ROLL CALL

Present: Mayor Petersdorf, J. Baumeister, E. Passenger, J. Freeland, R. Schmale, Attorney Gerber, City Recorder B. Stocking, Secretary D. Stinger

The record shows that there is one vacancy on the Council.

There were 45 citizens present.

II. APPROVAL OF MINUTES OF JANUARY 14, 1982

Action E. Passenger moved that the minutes of January 14, 1982 be approved. E. Fillman seconded and the motion carried.

#### III. BILLS AGAINST THE CITY

The Bills Against the City totaled \$1,626.33. E. Passenger asked if the Council could get an update of the road work that has been done in the City. Mayor Petersdorf asked the secretary to have the road chairman, Ira Mann get his report to the Council and to give a report at the next Council meeting.

Action E. Passenger moved that the Bills be paid. E. Fillman seconded and the motion carried.

- IV. RECEIPTS OF SESSION \$1,892.59
- V. CITIZENS INPUT ON UNSCHEDULED ITEMS

There were several citizens from the Woahink Trailer Park present to testify about the recent issue involving the trailer park and the sewer problem.

Mr. Gerber excused himself because of conflict of interest. He represents the trailer park in this issue.

Passenger, Petersdorf, Baumeister, Fillman all declared prior knowledge because they had been out on the property.

Mr. Garska, 83570 Hwy 101 S, Florence, Oregon was the first to testify. He stated that there had been raw sewage on the ground and running down the sand hill where the sewage is pumped. He stated that the County

Sanitarian had been out and said that the area was a health problem. He presented the Council with a letter from the Sanitarian stating this. Mr. Garska also stated that the park has been badly neglected, especially after the November storm. The management has told the tenants that the sewage problem is their problem. Mr. Garska stated that he would like to know who's problem it actually is.

Mr. Gerry Grey, Woahink Trailer Park, spoke in favor of the management and the Mobile Home Park.

Also speaking in favor of the management and the Mobile Home Park were: Pete Bizuko, Richard Albert, Mable Kimble, and J.A. Crum all of the Mobile Home Park.

Those speaking against the Mobile Home Park, declaring it a health hazard and badly neglected were: Joyce Ann Sousa and Bill Bagshaw.

Mr. Wally Johnson, J & V Excavating, Florence, testified as to the work he has recently done at the Mobile Home Park. He stated that he did pump the septic tanks after the storm in November. He also pumped them recently when all of this started. He now has a work permit filed to start work on repairing the system. For the upper part of the system he is waiting for a new drainfield to be designed by the DEQ. He stated that the problem with the lower septic was that they were never waterproofed and that ground water is running in all the time. This won't be able to be resolved until the water level goes down. The Lane County Sanitarian has been out and is working on the problem to resolve it.

The Council asked Mr. Johnson how much it would cost to pump the tanks every day. Mr. Johnson stated that it would be about \$300 per day plus  $2\frac{1}{2}$  cents dumpt fee, per gallon. The job would be about 8000 gallons. Another question asked was how long, in Mr. Johnson's opinion, would it take to remedy this problem. Mr. Johnson stated that possibly 30 days.

E. Passenger stated that if the upper drainfield is to go to the North of the Mobile Home Park, as the plan states, this is on Lane County property and it would have to go before the Lane County Planning Commission. This could take months.

Mrs. Verna Neill, assistant manager of the Mobile Home Park, testified to the problem. She stated that they did have problems with the sewer after the November storm because they did not have any power for five days and the sewer could not be pumped up the hill. The people should come to the management with their problems. She presented to the Council documents from the Water Analysis and a petition from several people, residents of the park, stating that they did not want the park closed. They were satisfied with the management.

E. Passenger gave her report on the findings of her investigation as Police Commissioner for Dunes City. She stated that she investigated the park and in her opinion there is a health hazard and it is in violation of Dunes City Ordinance #51. She stated that Dunes City can not get involved with management and tenants. Lane County has given until February 16 to see about the requirements for the system. Passenger suggested that the City put a moratorium on the park and not allow any more Mobile Homes into the park until the sanitaion problem has been corrected.

Action

- E. Fillman moved that the City declared the Mobile Home Park area a health hazard and a nuisnace according to the Dunes City Nuisance Ordinance #51. E. Passenger seconded.
  - J. Freeland asked if there had been any illness in the park due to the sanitation problem. The answer was no.

Ayes: Fillman, Schmale, Passenger, Baumeister

Nayes: Freeland

The motion carried.

J. Baumeister suggested that the City work on getting the DEQ to get things going.

The Council discussed this and decided to put this on the agenda for the special meeting of February 23 to discuss the progress on this issue. Mr. Johnson stated that he would attend this meeting and give a progress report.

Mayor Petersdorf suggested that the hillside where the septics are running over should be posted "No Trespassing" until this problem is corrected.

#### VI. ANNOUNCEMENTS AND CORRESPONDENCE

Mr. Gerber announced that he received papers from Mr. Larry Cooley, Mr. Lemke's attorney, stating that Mr. Lemke has filed an appeal with the circuit court stating that Dunes City's order for abating the nuisance was invalid and he is asking for a reverse in the order. Dunes City will be served in the next few days with these papers. Mr. Gerber stated that he would like to discuss this with the Council in an executive session later on in the meeting.

Florence Chamber of Commerce - KPNW - Mr. Hod Johnson from the Florence Chamber of Commerce presented a plan for advertising. He gave some examples that Florence is doing for promoting the Florence Area. He stated that they do include Dunes City in their promotions. He showed some examples of TV and Radio Commercials that Florence is doing. He explained how the Chamber of Commerce is financing these commercials. He was suggesting that Dunes City work with Florence in coordinating advertising for this area. He stated that the chamber of commerce would be holding their next meeting Wednesday, February 17, 9:30 a.m. at the Windward Inn. He invited anyone from Dunes City to attend.

Steve Murray from KPNW in Eugene was present to give some suggestions for some promoting commercials for Dunes City's Coastal Bass Classic, March 6 & 7. The Council discussed the possibilities for promoting Dunes City.

Mr. Murray gave the Council a proposal from KPNW for \$308.00 for 28, 30 second spots on the radio station.

Action

E. Passenger moved that the Council accept the proposal from KPNW promoting Dunes City and the Coastal Bass Classic, March 6 & 7 at the

cost of \$308.00 for 28, 30 second spots. E. Fillman seconded and the motion carried.

Mayor Petersdorf appointed R. Schmale to work with Mr. Murray on the commercials. He is to see that all of the correct and necessary information is given.

Councilman Resignation - B. Stocking read into the record Councilman J. Gwilliam's resignation. Council discussed the resignation and decided to advertise the vacancy and take the matter up at the regular March meeting.

Declaring Valentines Day - B. Stocking read into the record the Declaration from Marriage Encounters, declaring Valentines Day, February 14, 1982, "We Believe in Marriage Day". This was signed by Mayor Petersdorf on February 5, 1982.

Pacific Northwest | Bell, Rate Change - B. Stocking read to the Council parts of an article from the Siuslaw News concerning the base rate change from PNWB, in our area. There would be no more 4 party lines. In most cases the rates will go down. She gave a brief on how all of this came about.

Mr. John Carlson, Westłake, spoke for the Citizens Association stating that they have been working on this for several years and this change is a result of the Citizens Association's work and Dunes City's involvement in this beginning in March 1980.

LCOG dues- League of Oregon Cities Dues- B. Stocking stated that the City has received correspondence from both the League of Oregon Cities and LCOG stating that their annual dues will be going up. LCOG's will now be \$757 per year and League of Oregon Cities will be \$310.75 per year. This was discussed by the Council. Mr. Gerber stated that he personally, as the City's attorney, used the League of Oregon Cities a lot.

After more discussion the Council decided that this would be a budget decision and should be given to the budget committee for consideration when doing the 1982-83 budget.

# VII. REPORTS

Planning Commission Recommendation— The Planning Commission recommended to the City Council, Kevin McMullen to fill the vacancy on the Planning Commission.

Action E. Passenger moved that the City Council accept the Planning Commission's recommendation and appoint Kevin McMullen to the Planning Commission.

E. Fillman seconded and the motion carried.

Bus Shelter- D. Stinger gave a report on the Bus Shelter progress. She stated that the shelter at the intersection of Erhart and Clear Lake Road was up. She suggested that the City look into upgrading the rest of the Bus Shelters in the City. There are 9 shelters and only three of those 9 are in good shape. Also Muckleberry Lane is a large neighborhood and they do not have a shelter. Possibly paint and replacing boards to several of these shelters could be done. Council discussed this and decided that

D. Stinger could look into this further and find out how many of these

sheds are used a lot and which are no longer used. Possibly some could be moved to other areas where they will be used.

Retaining Wall - Ocean Blvd.- J. Baumeister stated that he looked into the maps of this area and could not come up with a definate City line. He could find nothing that showed where the City property ends and private property starts. There was some discussion about the water level of the lake and where the water line was. Mayor Petersdorf suggested that the committee get a hold of Herb Sauter. He should recall where the line is and also look for some updated maps. This issue will be tabled until it can be looked into further.

Cable T.V. - J. Freeland gave a short report on what the committee has been doing with the negotiations with the Cable T.V. concerning the franchise agreement. They have decided that there is a need for a consultant in the matter. This will involve getting funds from the City. They have also decided that there is a need to advertise for bids on the franchise. The next meeting of the committee will be on February 18, 4:00 P.M. to interview two consultants.

Mr. Gerber gave a brief on what is happening with the negotiations.

John Carlson, spoke out on the issue. He did not feel that a conslutant was very necessary and he did not agree with the 20 year franchise. He felt that we should give a chance for competition. He suggested that rather than hire a consultant, the City could pay one of the committee members for their time and expenses to check into this further. The Council felt that this is already beging checked into by the committee members but that none of them felt that they knew enough about Cable TV systems. This is why the need for a consultant.

Dave Clark, Attorney for the Florence Cable TV System, spoke out on the subject. He stated that the sale between Florence Cable TV and McCaw Ent. is in jeapordy. There has been bad communication between all parties. McCaw is not getting information that they have asked for and the cities are not getting information that they are asking for. He felt that everyone should get together and talk instead of going through all of these other channels.

Mr. Gerber stated that he has drafted a franchise ordinance for the City to consider. This will not be considered until the special City Council meeting of February 23. The Council is too look over this and be ready for input.

Marilyn Adkins, Central Lincoln PUD, was present to speak on the proposed franchise ordinance. She stated that Central Lincoln PUD is a franchise holder with Dunes City and they felt that they should have a copy of the proposed ordinance and have the opportunity for input. Mr. Gerber stated that all franchise holders would get a copy and have the opportunity for input.

Council felt that the committee was doing a good job and they would wait to hear from the. at the next meeting.

Economic Diversification Committee - E. Fillman gave a report on the committee's last meeting. He stated that they worked a lot with the Port of Siuslaw and had talked of a larger tax base to develop some of the Port's property. The next meeting they are to discuss the City of Florence's Industrial Park. That meeting will be on February 16, 1982.

Carolynda Erskine, Florence Chamber of Commerce President, was present and gave Mr. Fillman the minutes of the last committee meeting. She stated that they have been working hard on  $\dot{\Phi}$ deas to get the community back to work.

E. Fillman mentioned that the recent cancellation of the funds for the jetty extentions, by President Regan, will be causing a lot of problems in this area.

#### VIII. EXECUTIVE SESSION

Executive session was called by Mayor Petersdorf at 10:20 P.M. to discuss litigation.

The regular meeting reconvened at 10:29 P.M.

#### IX. UNFINESHED BUSINESS

Ordinance #51-1210 - E. Fillman moved to have the second reading of Ordinance #51-1210 by short title. E. Passenger seconded and the motion carried.

Mr. Gerber gave the second reading of Ordinance #51-1210 by short title.

Action E. Fillman moved to accept the second reading of Ordinance #51-1210 by short title. J. Baumeister seconded an

Ayes: Baumeister, Fillman, Freeland, Passenger, Schmale

The motion carried.

Dunes City - Westlake Post Office - Mr. John Carlson presented a letter to Council with some of his and other citizens concerns about such a change. He also gave Council a petition signed by 47 of 50 citizens surveyed, all against changing the Westlake Post Office to Dunes City Post Office. He also stated that the possibility of the post office being closed down could exist.

Council discussed this and felt that this possibility was very unlikely. After more dsicussion, it was decided to table the matter for future consideration.

Resolution 2-11-82 - Occupancy Permit  $\stackrel{?}{\rightarrow}$  The Council discussed the revised form of the resolution to adopt fees for occupancy permits, road construction permits, and road excavation permits.

It was decided that the first paragraph would be deleted and in the second paragraph the last word "and" should be deleted and the words," or construction within a public right of way" should be added.

Under the fees, \$15 for issuance of a road construction permit and \$15 for issuance of excavation work permit, would be put in.

Action

E. Fillman moved to acdept Resolution 2-11-82 with corrections. J. Freeland seconded and the motion carried.

911 Emergency System- Mr. Gerber gave a brief on this issue. He stated that the 3% surtax would be collected by the State and distributed to cities with the system. At this time the money can only be used for expanding the System or buying new equipment. Dunes City may receive about \$3000.

Since Dunes City does not dispatch the system, the money can go to the City of Florence. Mr. Gerber and Mayor Petersdorf gave a brief update on a meeting they had with P-lice Chief Shaw of Florence concerning this.

Gerber stated that he would draw up another agreement and have it ready for the February 23 special meeting of the Council.

Action

- E. Fillman moved to continue to New Business since it was past 11:00 P.M.
- E. Passenger seconded and the motion carried.

#### X. NEW BUSINESS

Increase Utility Rates - WPPSS - The Council discussed the WPPSS bonds and the increasing power rates.

John Carlson gave input on this issue. He stated that from his research the Central Lincoln PUD was justified in signing their part in this. They are not bound to taking it to the people for a vote.

Action

J. Freeland moved that Dunes City go on record as being opposed to paying any part on the WPPSS bills. E. Fillman seconded and the motion carried.

#### SPECIAL MEETING

# FEBRUARY 24, 1982

# I. CALL TO ORDER AND ROLL CALL

The special meeting of the Dunes City Council was called to order by Mayor Petersdorf at 7:36 P.M. on the 24th day of February, 1982.

Roll Call

Present: Mayor Petersdorf, E. Fillman, J. Baumeister,

R. Schmale, E. Passenger, Attorney Gerber,

City Recorder B. Stocking, Secretary D. Stinger

Absent: Jack Freeland (excused)

The record shows that there is one vacancy on

the Council.

There were 19 citizens present.

#### II. PUBLIC HEARING

Mary Watts- Conditional Use Permit 4386 Pacific Ave., Westlake, Oregon 19-12-34-2-1- TL # 1000

The PUblic Hearing for Mary Watts was opened at 7:38 P.M.

Judy Smith, Dunes City Planning Commission was present to give the Planning Commission's recommendation from the meeting held on Monday February 22, for the Watts Conditional Use Permit request. The Planning Commission's recommendation was that the CUP request for Mary Watts be tabled until further information and recommnedations were received from the Lane County Sanitarian and that the Stop Work Order issued February 8, 1982 be enforced effective March 1, 1982, 8:00 A.M. at \$250 per day fine. The Planning Commission also recommended to the City Council that a representative of Surf Mobile Homes be requested to appear at the February 24, 1982 hearing before the City Council.

J. Smith also stated that the Planning Commission felt that as long as someone was staying in the Mobile Home, the Stop Work Order was being violated.

Mr. Elmer Peterson, Westlake, spoke for the Watts CUP. He asked

whether the \$250 per day fine would start from 2-8-82. He didn't feel like all of this fuss was necessary. The Watts' were doing their best to fix things although he realized that they did not go through the proper channels.

There was no one present to represent the Watts'. The Public Hearing was closed at 7:43 P.M.

The Council had a question on whether there was another trailer on the property. J. Smith stated that there was another trailer that the grandmother lives in. The property that this trailer is on was once Hemlock street and it was vacated and became part of the Watts' lot #1000. By todays standards, it would be considered a travel trailer. However, it is lived in full time and the Planning Commission was told at the meeting of 2-22-82, that there was a separate septic for this trailer.

The City Recorder stated that Mrs. Watts had been in that day and said that she had had Wally Johnson of J & V Excavating out to look at the septic. Mr. Johnson was in the audience and was asked to speak on this.

Mr. Johnson stated that he was asked to verify that there was a 1000 gallon capacity in the Watts' system. He stated that they had two 500 gallon metal tanks. He did not feel that they would be passed by the county because they were metal, but this is just his feeling. All he was aksed to do was to verify that they had a 1000 gallon capacity, which they do have.

The Public Hearing was reopened at 7:51.

Mr. Mike Watts, Mrs. Watts' son was present to testify. He stated that he had been in contact with the County Sanitarian and was told what had to be done. They told hime that they could put in 150' of leach line and 6" of rock with some visquine over the rock before covering with dirt. He was told over the phone that the metal tanks would be OK as long as the metal was in good condition. Although the sanitarian that was down here told his brother that the metal would not be alright that a fiberglass tank would have to be put in.

Council discussed this a length. Also Mr. Watts stated that he felt that his Mother had the right to stay the night in the Mobile Home. Mayor Petersdorf stated that when the Stop Work Order was served the Mobile Home movers were told to move the mobile off of the road and not to be blocked up because it may have to be moved out again. It should not be stayed in. There should be no cooking going on in the mobile.

The Council discussed the septic permit further. D. Stinger stated that the County has issued a permit to repair the system. They are not denying a septic permit, they just want the septic repaired to bring it up to standards. Really, they do have a permit that says a septic system is allowed. The CUP permit could be approved with

the condition that the Mobile HOme is not set up until the City has the signed final approval of the Lane County Sanitarian. The City has done this before.

The Public Hearing was closed at 8:15.

After more discussion a motion was made.

Passenger moved that the CUP be tabled until further information on the septic approval from the Lane County Sanitarian was received and that no one live in the Mobile Home until this is received. Fillman seconded.

Attorney Gerber stated that the way the motion was stated, another Public Hearing would be required to approve the CUP.

Passenger withdrew her motion and Fillman withdrew his second.

Action

Baumeister moved that the Conditonal Use Permit for Mary Watts, 4386 Pacific Ave., 19-12-34-2-1-TL#1000, Westlake, Oregon, be approved contingent on the approval of the Lane County Sanitarian for the septic system with the following conditions:

- 1. The Mobile Home not be occupied until the CUP has become effective.
- 2. A Building Permit to install the Mobile Home not be issued until the sanitarian approval has been received by the City.

Passenger seconded and the motion carried.

The record shows that E. Fillman did not vote.

# III. UNFINISHED BUSINESS

Woahink Mobile Home Park- The Council was to hear a progress report on the findings from the DEQ on the septic problem with the Mobile Home Park. Mr. Gerber stepped down because of conflict of interest, as stated at a prior meeting. Mr. Duane McCabe, P.O. Box 187, Reedsport, Oregon 97467, stepped in to represent the City as their attorney.

Mr. McCabe asked the Council if the evidence that was submitted at the February 11, 1982 City Council meeting and the signed complaint submitted at that same meeting, was made a part of the City's records.

The City Recorder and the Secretary both stated that the information was given to the Council for review at the February 11th meeting but the information never got to the City Recorder's desk so the file does not have the complaint.

Mr. Skip Garska, the complainant, gave the Council another written complaint.

Mayor Peterdorfs stated that possibly the information had gotten

mixed up in his packet and he took it home. He would leave to go look.

Mr. McCabe stated that as long as the Council saw it and it is in the minutes that it was submitted, the Council could go on with the proceedings.

E. Passenger read parts of a letter from the DEQ into the record. The letter concerned the repair of the system and all that would have to be done.

Mr. McCabe stated that the Council had two alternatives to deal with this. The first would be to go ahead and start abatement proceedings to abate the nuisance or the Council could ask for voluntary compliance from the owner in repairing the system. If the City goes ahead with abatement, the owner would have to comply within the time stated.

Mr. Wally, Johnson, J & V Excavating, stated that he had been up there and dug some ditches and worked on the system some, and the biggest part of the problem had been resolved although there is some more repair that needs to be done. He stated that as far as the DEQ's request, he didn't feel that a whole new system was necessary. The system was there had worked for several years and with some repair it can work for several more years. The new system has been estimated at costing about \$75,00. Mrs. Thompson , the owner, may very well. close the palce when she hears this figure.

Mr. Garska, Woahink Trailer Park, stated that to insure that the system will be fixed, why not have Mrs. Thompson put up a performance bond on the repair to make sure it gets done and that it is done right.

(The record shows that the tape recorder was not working to this point in the meeting).

Joyce Ann Sousa, Woahink Trailer Park, stated that since the work had been done, the sewage is not backing up in her yard any more. Also she asked if they had to wait until April 15th, as the DEQ letter stated, to know if they will have to move or if the system will be replaced.

Council stated that if they choose to go with abatement proceedings, there will be 10 days that Mrs. Thompson has to let the City know what she will do.

Action

Baumeister moved that Dunes City go ahead with proceedings to abate according to the Dunes City Ordinance #51 ,notifying the owner, Mrs. Alice Thompson, she had ten(10) days from the time the property is posted, to respond to the DEQ's letter of requirements for the system. Fillman seconded . The motion carried.

The question was raised as to whether any more Mobile Homes would be allowed into the park until this is resolved. City Recorder, B. Stocking stated that she has letter from the Building Inspector, Emile Mortier, stating that the Mobile Home Park has not been applying

for Mobile Home Installation Permits when a Mobile Home is moved in. Mr. Mortier has sent a letter to the park stating that he will not issue any permits for the park until the septic system problem is resolved.

Mayor Petersdorf stated that the property would be posted on Friday 2-26-82 and that Mrs. Thompson has ten days from that date to respond to the City.

Mr. Garska also stated that the area where the work had been done and the holes were dug, he had noticed, has been driven through by dune buggies and 4-wheel drive vehicles. He felt that the park had a great risk of liability of someone getting hurt by falling in the holes. He suggested that the City have this posted, "NO TRESPASSING".

The Council stated that they did not have the authority to have this posted. This was up to the management and the owner.

Mr. McCabe stepped down and Mr. Gerber returned,

911 Agreement- Mr. Gerber gave a brief on this intergovernmental agreement to the City Council. It was discussed at length.

Passenger moved that the City Council instruct Mr. Gerber to draw up Accion with the City of Florence, an intergovernmental agreement concerning the 911 Emergency System and give the Mayor the authority to sign this agreement after each of the Council members has received a copy and had time to respond. Fillman seconded and the motion carried.

> Franchise Ordinance- Mr. Gerber stated to the Council to recall when the City got into this Cable TV business, there was some thought as to how we were going to proceed with the request to transfer the franchise After we got into it, it appeared to him that it would be easier to draft an overall ordinance that delt with refranchising, transfer, of franchise and application of franchise and that is what this ordinance is attempting to do. This was drafted and presented to the Council at the last meeting so all of the Council would have a chance to look at it.

Mr. Gerber stated that he heard from Mr. Bruce Hall, the area public relations man for PNWB. He raised certain objections to this ordinance. The point that he was making was that in the franchising business the City's frequently franchise operations which are partially or wholaw regulated by State or Feberal authorities. Some parts of our ordinance duplicate this and sometimes conflict with these regulations. Mr. Gerber felt that Mr. Hall was correct there. was discussed with Mr. Hall over the phone and Mr. Gerber stated that he took some of his suggestions and incorporate them into what he has called the preamble of the ordinance and this is what was just handed out to the Council.

The Council discussed the preamble and several other sections of the ordinance at length. There was testimony from Mr. Jack Snock,

Central Lincoln PUD., Newport, Oregon stating Central Lincoln is one of those organizations that are directly controlled under Oregon State Statues. After going over the City's proposed ordinance if Central Lincoln's Franchise were to expire and we were to try to renegotiate the franchise, it would be impossible under this ordinance, because we would be preempted from probably 99% of this ordinance. If the Council wishes to persue this type of ordinance it is our feeling without talking to our attorney, you would make a direct exception for special service districts. These districts are covered under your Chapter of ORS and because of this they are preempted anyway.

The City is going through a whole ritual that could tie things up for future negotiations with the franchise. The Central Lincoln PUD would like a complete copy of the revised ordinance for their attorney to look at. He is on vacation now and has not had the opportunity to look at the ordinance.

Gerber suggested that a resolution drafted at the time of adoption, exempting the PUD, that way if something ever did happend and you deregulated, we could take a look at what we could not see anything wrong with this, but their attorney has not had the opportunity to look at this.

This was discussed further and the special services clause was discussed.

Also Mr. Mike Johnson, Siuslaw Sanitary SErvice, Florence had some comments as a franchise holder with Dunes City. He directed the Council to several sections of the ordinance that he felt was directed for his competetor and trying to put him out of business.

Mr. Dave Clark, attorney for Florence Cable TV, also viewed some objections with the ordinance. He had objections with Section 4, d, (1) concerning service from volunteering charitable, community, civic or benevolent purposes. This was discussed at length by the Council and Mr. Clark. There were several charges to this paragraph made.

After all of the discussion. Mr. Gerber stated that he would not be prepared to give a first reading of the ordinance at this meeting.

The Council went into Executive Session to discuss an employment contract for an agent of the City, and potential pending litigation and to discuss some confidential memorandums submitted to the City Council. The session was called at 10:55.

The Special Meeting of the City Council reconvened at 11:26 P.M.

Passenger moved that the City of Dunes City participate with the City of Florence in the hiring of Stephen Jolin to be hire as a consultant on the negotiating of the Cable TV Franchise at sharing the cost and Dunes City's cost being \$500. Fillman seconded and the motion carried.

A ion

Action

Fillman moved that the City authorize the attorney to send the coauthored letter from the joint committee to Mr. Percell. Baumeister seconded and the motion carried.

Mr. Gerber stated that he heard from Jerry Rust of Lane County indicating that he thought that the county would be prepared to join our negotiating agreement if we would agree that:

- 1. There would be no cost to the County.
- 2. The committee would meet and make a presentation to the county at their meeting.
- 3. That any agreement that was reached would not be binding on the county, until the board approved it before the County Commissioners.

He asked the Council for the authority to meet with the attorney's for the City of Florence to draft up some sort of agreement with the county and to have this ready for the next meeting.

Action

Fillman moved that the City authorize the City attorney to get with the City of Florence's attorneys and draft an agreement to enter in with Lane County Commissioners as stated by the attorney and report back at the next Council meeting. Baumeister seconded and the motion carried.

Passenger moved that the City authorize the City Attorney to send a letter to Nicholson and Clark as discussed in executive session. Schmale seconded and the motion carried.

IV. ADJOURNMENT - 11:40 P.M.

#### I. CALL TO ORDER AND ROLL CALL

The regular meeting of the Dunes City Council was called to order by Mayor Petersdorf at 7:30 P.M. on the 11th day of March, 1982.

Council has one vacancy.

Mayor Petersdorf stated that Mr. McCabe is sitting in for Attorney Gerber. Gerber will not be to the meeting until later on.

II. APPROVAL OF MINUTES OF FEBRUARY 11 and FEBRUARY 24

ACTION E. Fillman moved that the minutes of February 11 be approved with corrections. J. Freeland seconded and the motion carried.

ACTION J. Baumeister moved that the minutes of the special meeting of February 24 be approved as presented. J. Freeland seconded and the motion carried.

III. BILLS AGAINST THE CITY

ACTION

The bills against the City totaled 1,072.89. Mayor Petersdorf asked why the bills from KPNW was not the full 308.00. B. Stocking stated that we were just billed for the days in February. We will be billed for the days in March this month. E. Fillman moved that the bills be paid. Baumeister seconded and the motion carried.

IV. RECEIPTS OF SESSION - 5,433.10

V. CITIZENS INPUT ON UNSCHEDULED ITEMS

Mr. John Carlson, Westlake spoke to the Council about the house over on the old Railroad to the Dunes on the West side of HWY 101. He stated that he found out that the NRA was going to tear down the house and return the land to it's original state. He has been working on an idea for that house because he hates to see it torn down. He got in touch with an organization called the American Youth Hostels. It is an organization that provides housing for bikers and hikers to stay in at night and cook their food and have a shower, etc. The closest one on the Oregon Coast is in Coos Bay in a Church building.

Also there is one in Bandon. This service is offered only to members of the American Youth Hostel and the homes are only open from 8:00 P.M. until 9:00 A.M. Each person staying there is charged a small fee and them is required to put in about a half an hour of their time cleaning up etc.

Mr. Carlson stated that he felt that this house on the NRA property would make a great Youth Hostel. They like to have them about 40 miles apart and this is about 42 miles from Coos Bay. Also it is in a remote area where the kids could not bother anyone. He also stated that the house would need a lot of repair and the cost would be about \$15,000. Also it would require about 60 voluteer hours of labor. He stated that he was here to inform the Council of his findings. He doesn't know if the National Association of Youth Hostels will put up the money for the project and also it has to go before the County for Planning OK.

The Council discussed this and all felt that they also would hate to see this house torn down. Council decided that they would write letters supporting the project to Rick Scott of the NRA, Lane County and the American Youth Hostel Association.

James Flatley and Jim Pearson from the Coastal Bass Club were present to tell the Council thank you for the support before and during the Coastal Bass Classic. They stated that it was a big success and that they would like to have the City's support again next year. Also there was some discussion on the possibility of holding the tournament at the County boat launch in Westlake next year because there is more parking and better docking.

#### VI. ANNOUNCEMENTS

Congratulation Certificates- Mayor Petersdorf presented to the Council a brochure on some Congratulation to Graduating Seniors, Certificates. He stated that he felt this was a good idead and a personal way to congratulate the High School Seniors. The cost would be \$35 for a box of 100.

ACTION

J. Freeland moved to have the City spend \$35 for the Congratulation Certificates, as presented to the Council. Baumeister seconded and the motion carried.

<u>Planning Commission Resignation</u>— The Planning Commission's chairman Bob Camera has submitted his resignation from the Planning Commission effective March 9, 1982.

ACTION

- J. Freeland moved that the Council accept Bob Camera's resignation.
- J. Baumeister seconded and the motion carried.

# VII. REPORTS

Roads- The Council had a copy of the Road Report for February and March. In the report, the road committee had approved a raise for the road chairman from \$50 per month to \$100 per month.

Mayor Petersdorf stated that the road committee does not have the authority to give the raise. This is something that has to be taken up at budget time in June. He suggested that this be tabled until budget time and until there is a chance to talk to the road committee regarding their reasons for this raise.

Audit Report - Mayor Petersdorf stated that the Council needs to approve the audit report. All Council members should have had the report long ago. A few members stated that they just got it and did not feel that they could approve it until they have studied it further.

ACTION

J. Freeland moved that the Council look over the Audit Report further and table the approval until the next City Council meeting. Baumiester seconded and the motion carried.

# VIII. PUBLIC HEARING

H.R. HEGGEN - VARIANCE 5492 Little Woahink Florence, Oregon 97439 19-12-11-4 TL#101

The Public Hearing for H.R. Heggen was opened at 8:05.

D. Stinger gave the Planning Commission's report to the City Council. Also the Findings of Fact and Conclusions of Law were read. The Planning Commission's recommendation was to approve the variance request with the conditions that no trees be removed from the property line. Also D. Stinger stated that the City had received a call from Mortier stating that he needed to have a copy of the recorded deed restriction on the middle Bucko parcel that stated that no building could take place from the west property line to the barn on that parcel. The City now has a copy of the recorded deed in the file.

Mr. Heegen was present and only stated that he would like to have his variance approved.

The Public Hearing was closed at 8:10.

Mayor Petersdorf stated that on the Findings of Fact, the parcel was said to be 2.17 of an acre, however, on the map it states 2.12 of an acre. This should be checked to see which is correct. D. Stinger stated that on one map it is hard to read and it looks to be 2.17 but it should be 2.12.

ACTION

E. Fillman moved that the City Council adopt the Findings of Fact and Conclusions of Law found by the Planning Commission and accept recommendation of the Planning Commission and approve the variance request of H. R. Heggen, 5492 Little Woahink, Florence (located in Dunes City), 19-12-11-4 TL #101, with the condition that no trees be removed from the property line. Schmale seconded and the motion carried.

#### IX. NEW BUSINESS STATES

Council Vacancy- Mayor Petersdorf stated that the City has received two applications for the Council vacancy. He appointed a committee to interview the applicants and to come to the next City Council meeting with a recommendation for the vacancy. The committee is J. Freeland, R. Schmale, and Mayor Petersdorf.

Westlake Store - Mayor Petersdorf stated that Mr. Strenke of the Westlake Store has come to the City Office inquiring about having gasoline at his store again. He stated that the previous owner let the license expire and he is trying to get the license again. However, he is supposed to have \$5000 of grocery inventory in his store before the State will grant the license. Also there was some discussion on the fact that Mr. Strenke is thinking about having an above ground gas tank for outboard motor gas. This was discussed by Council and they all felt that this would not be good in a residential area.

B. Stocking stated that she was feeling that maybe if the City had no abjection to Mr. Strenke having gasoline at his store again that maybe the process of his license being approved could be hurried. Council stated that they had no objection to having gasoline, but that they did to his having an above ground tank. Mayor Petersdorf said for the City Recorder to get in touch with Mr. Strenke and tell him to Council feelings.

Vacated Streets - Baumeister reported that during his research in the Ocean Blvd. Retaining Wall he has found that the County has no record of any streets in Dunes City being vacated. Therehave been several streets vacated, but they have no record. He felt that the City needed to do some digging and find the Council action on these streets and get an accurate record recorded. Also he stated that there is a need for an accuate record of private and City owned streets. There seems to be a lot of confusion on this. The road committee is not even sure.

Mayor Petersdorf stated that J. Freeland is the Road Commissioner and should work with the road committee on this.

Mr. Gerber arrived at 8:45. Mr. McCabe stepped down.

#### X. OLD BUSINESS

911 Agreement- Gerber stated that all of the Council received copies of this agreement and there were no objections so it was signed by the Mayor. Dunes City is now contributing their percent of the 911 tax to the Western Lane System.

Agreement with County Regarding Cable TV Franchise- Gerber stated that there has been an agreement drafted and approved by Florence and Dunes City and it has been presented to the County Commissioners, however, there has been no word from them at this time.

<u>Franchise Ordinance</u>- Gerber gave a brief on this Ordinance. He also stated that there has been a resolution drafted that will be presented at the second reading of this Ordinance regarding the Franchisees pre-empted from the Ordinance.

Mayor Petersdorf stated that he had spoke to E. Passenger and she had stated that she did not feel that she had a good enough understanding of the ordinance and that she was against any reading taking place at this meeting.

Council went through the Ordiance and made a few more changes in it. It was also stated that this Ordinance would be numbered #73. After more discussion, R. Schmale stated that he also did not have a good understanding of the Ordinance and would not like to have a reading of it yet.

J. Freeland asked Mr. Gerber if he felt that this Ordinance gave the City a good footing. His reply was, yes. Gerber also stated that since the second draft was sent to the franchise holders, there had been no objections viewed from any of them.

ACTION

J. Baumeister moved that the first and second reading of Ordinance #73 be tabled until the April City Council meeting . E. Fillman seconded and the motion carried.

# XI. EXECUTIVE SESSION

Council went into executive session at 9:28 P.M. This was to discuss a Confindential Memorandum and a settlement from Mr. Lemke's Attorney.

Council reconvened at 9:53 P.M.

Mr. Gerber stated that the settlement offer from Mr. Lemke's Attorney was asking that Dunes City drop \$2500 of their original \$5000 find against Mr. Lemke and leave the total cost against Mr. Lemke at \$2500 in fines and \$3170.76 for costs, for a total of \$5670.76. This is to be paid to the City in monthly installments of \$500 per month and this payment was guaranteed by Herb Robbins. Mr. Gerber went on to say that the first payment would be due by April 1 and if any payments are received after the first of any month, the additional \$2500 fine would be reinstated.

ACTION

J. Freeland moved that the City Council accept the settlement proposed by Mr. Lemke with the payment schedule as read into the record by Attorney Gerber. J. Baumeister seconded and the motion carried.

E. FILLMAN SECONDED AND THE MOTION CARRIED.

- IV. RECEIPTS OF SESSION 6,298.86
- V. CITIZENS INPUT ON UNSCHEDULED ITEMS

LOREN PARKER, 2076 16TH STREET, FLORENCE, OREGON, OWNER OF WEST LANE DISPOSAL SPOKE ON DUNES CITY'S SOLID WAST DISPOSAL ORDINANCE.

MR. GERBER DECLARED CONFLICT ON INTEREST AND STEPPED DOWN. MR. BOB LAIRD SAT IN AS THE CITY'S ATTORNEY.

MR. PARKER STATED THAT IN 1977 WHEN THE ORDINANCE WAS APPROVED, HE WAS SURE THAT IT WAS NOT THE INTENT OF THE CITY THAT THE FRANCHISE BE USED AS AN INSTRUMENT TO CREATE AN UNFAIR COMPETATIVE MARKET IN THE GARBAGE BUSINESS. UNFORTUNATELY THIS IS WHAT HAS HAPPENED. HE WENT ON TO EXPLAIN TO THE COUNCIL THAT SIUSLAW SANITARY SERVICE, THE DUNES CITY FRANCHISEE, HAS OFFERED A VERY LOW RATE TO A FEW OF WEST LANE DISPOSAL'S CUSTOMERS OUT IN THE

UNINCORPORATED AREAS. THIS IS UNDERPRICING. MR. PARKER STATED THAT HE UNDERSTOOD THAT LEGALLY THERE WAS NOTHING THAT DUNES CITY COULD DO ABOUT THIS BUT THAT POSSIBLY IT WAS THE DUTY OF THE CITY TO REQUEST THAT SIUSLAW SANITARY SERVICE OFFER THE SAME LOW RATES TO THE CITIZENS OF DUNES CITY. MR. PARKER ALSO STATED THAT HE IS GOING TO GET A COMMITTEE OF DUNES CITY CITIZENS TOGETHER TO INITIATE A REFERENDUM TO PUT BEFORE THE VOTERS THAT WOULD ASK THAT THE PRESENT SOLID WASTE ORDINANCE BE REPEALED. HE WENT ON TO SAY THAT THE REASON HE WAS PRESENT AT THIS MEETING WAS TO ASK THAT THE COUNCIL TAKE THAT INITIATIVE AND PLACE THAT PROPOSAL ON THE BALLOT YOURSELF.

COUNCIL DISCUSSED ALTHERNATIVES OF REPEALING AN ORDINANCE. MR. PARKER STATED THAT THE ONLY RATE BASE STATED IN THE CONTRACT WITH SIUSLAW SANITARY SERVICE WAS FOR RESIDENTIAL CUSTOMERS. THE COMMERCIAL CUSTOMERS WERE TO DEAL WITH SIUSLAW SANITARY ON THE RATE. MR. PARKER STATED THAT WHAT MIKE JOHNSON IS DOING IS USING HIS FRANCHISE TO HOLD UP THE COST IN THE INCORPORATED AREAS AND THEM THERE IS NO JUDGEMENT TO THE COSTS IN THE UNICOPORATED AREAS. HE IS PROTECTED FROM COMPETITION IN THE CITIES BUT IS ALLOWED TO COMPETE WITH WEST LANE IN THE UNINCORPORATED AREAS.

THE COUNCIL DISCUSSED RESOLUTION 6-12-80 A, AMENDING REFUSE COLLECTION FRANCHISE SERVICE FEE CHARGE.

MAYOR PETERSDORF SUGGESTED THAT THE CITY CHECK TO SEE IF MR. JOHNSON WOULD APPEAR AT A CITY COUNCIL MEETING AND ADDRESS THE QUESTION. THE CITY RECORDER WAS INSTRUCTED TO NOTIFY MR. JOHNSON FOR THE NEXT CITY COUNCIL MEETING.

MR. GERBER RETURNED TO SDT WITH THE COUNCIL.

#### VI. ANNOUNCEMENTS AND CORRESPONDENCE

P.U.D. ADVERTISEMENT- B. STOCKING STATED THAT THE CITY PUT AN AD IN THE PAPER A FEW MONTHS BACK REGARDING THE HIGH UNTILITY BILLS. WEASKED FOR A RESPONSE FROM CITIZENS. THE CITY RECEIVED 8 RE-SPONSES AND THESE PEOPLE WERE WILLING TO ATTEND A PUBLIC HEARING OR ADDRESS LETTERS, ANYTHING TO FIGHT THESE UNTILITY BILLS, ESPECIALLY WHERE THE WPPSS EXPENSES WERE INVOLVED. THE COUNCIL DISCUSSED THIS AND THE FACT THAT THE CITY DID SEND A LETTER TO CENTRAL LINCOLN PUD, STATING THAT DUNES CITY WAS GOING ON RECORD AS BEING OPPOSED TO PAYING ANY PART OF THE WPPSS EXPENSES. MAYOR PETERSDORF SUGGESTED THAT THE CITY RECORDER WRITE BACK TO THESE CITIZENS INSTRUCTING THEM OF WHERE THEY MAY WRITE, PUD BOARD OF DIRECTORS, CONGRESSMAN, ETC. SO THAT THEIR OPINION MAY BE CONSIDERED.

EMERALD PUD LETTER- THIS LETTER WAS READ INTO THE RECORD. THE LETTER DELT WITH THE POSSIBILITY OF LANE COUNTY WORKING ON BEING ENERGY SELF SUFFICIENT. THEY FELT THAT THERE WAS ENOUGH POTENTIAL IN LANE COUNTY, TO CREATE ENOUGH ENERGY ALONG WITH CONSERVATION TO BE SELF SUFFICIENT. THE LETTER WAS ASKING IF DUNES CITY WOULD BE INTERESTED IN PARTICIPATING WITH THIS COMMITTEE.

THE COUNCIL DISCUSSED THIS BRIEFLY AND DECIDED THAT THEY WOULD NOT

RESPOND TO THIS LETTER.

YOUTH HOSTELS- B. STOCKING STATED THAT SHE WROTE LETTERS TO THE COUNTY PLANNING, YOUTH HOSTELS HEADQUARTERS AND RICK SCOTT OF THE NRA. THE CITY RECEIVED A RESPONSE FROM RICK SCOTT AND HE STATED THAT THERE HAD BEEN SEVERAL PROPOSALS FOR THE USE OF THE TIMBER DUNES BUILDING AND FORMS HAD BEEN SENT TO THESE PEOPLE AND THE NRA HAS NOT RECEIVED ANY OF THESE FORMS BACK YET. IF THEY DO NOT RECEIVE ANY OF THEM BACK, THEY WILL GO AHEAD AS PLANNED AND DESTROY THE BUILDING AT THE END OF MAY.

# WOAHINK MOBILE HOME PARK RESORT

THE PUBLIC HEARING FOR THE MOBILE HOME PARK WAS OPENED AT 9:09. MR. GERBER STEPPED DOWN BECAUSE OF CONFLICT ON INTEREST AND MR. BOB LAIRD STEPPED IN FOR THE CITY.

MR. LAIRD PRESENTED TO THE CITY RECORDER 4 EXHIBITS TO BE RECORDED AND THEN PASSED ON FOR COUNCIL TO REVIEW. EXHIBIT 1, LETTER OF 2-9-82 TO ALICE THOMPSON FROM JOHN STONER, LANE COUNTY ENVIRON-MENTAL HEALTH. EXHIBIT 2, LETTER DATED 2-10-82 TO JOHN WALLACE, (WALLY JOHNSON), J & V EXCAVATING REGARDING THE REAPIR PERMIT, FROM RAY BURNS, LANE COUNTY SANITARIAN. EXHIBIT 3, LETTER DATED 2-23-82 TO LARRY BOSKOW, PLANTS & ASSOCIATES, REGARDING WOAHINK MOBILE HOME PARK FAILING SEWAGE SYSTEM, FROM GARY MESSER, DEQ. EXHIBIT 4, LETTER DATED 4-8-82 TO MAYOR PETERSDORF, DUNES CITY, REGARDING NUISANCE ABATEMENT HEARING ON WOAHINK MOBILE HOME PARK, FROM ANN BUNNENBERG, ATTORNEY FOR ALICE JOHNSON.

ANN BUNNENBERG, 295 W 5TH ST. EUGENE, OREGON SPOKE FOR THE MOBILE HOME PARK. SHE REFERED TO THE EXHIBITS THAT WERE SUBMITTED. SHE STATED THAT THERE WAS SOME QUESTION AS TO WHETHER THE NUISANCE PROCEEDINGS WERE DONE PROPERLY.

MR. LAIRD STATED THAT PROPER NOTICE HAD NOT BEEN GIVEN ACCORDING TO THE NUISANCE ORDINANCE, SO THE COUNCIL IS BACK AT SQUARE ON AS TO DECLARING A NUISANCE.

MS. BUNNENBURG DISCUSSED THE DEQ'S LETTER OF REQUIRMENTS, STATING THAT MRS. THOMPSON HAS COMPLETED PHASE ONE OF THE REQUIRMENTS. DITCHES WERE DUG TO TAKE CARE OF THE OVERFLOW OF THE SYSTEM. ALL OF THE SEWAGE DOWN IN THE MOBILE HOME PARK HAS BEEN TAKEN CARE OF. THEY HAVE CONTACTED PLANTS & ASSOCIATES FOR AN ENGINEERED PLAN OF REQUIREMENTS. THERE IS A POSSIBLITIE THAT THE SYSTEM WILL BE APPROVED TO REPAIR RATHER THAN TO REPLACE THE ENTIRE SYSTEM AT ABOUT \$70,000.

MR. LAIRD STATED THAT COUNCIL NEEDS TO BE CONCERNED WITH WHETHER A NUISANCE DOES EXIST. THE COUNCIL SHOULD BE CONSIDERING SECTION 6, B OF ORDINANCE #51.

E. PASSENGER STATED THAT AS LONG AS THE SYSTEM IS NOT WORKING, APPROVED BY THE DEQ, THEY ARE IN VIOLATION OF THE ORDINANCE.

VERNA NEILL, ASSISTANT MANAGER, OF WOAHINK MOBILE HOME PARK, STATED THAT THE PARTIES THAT STARTED ALL OF THIS COMPLAINING HAVE MOVED FROM THE PARK. THEY DID FIND THAT A LOT OF THE SURFACE SEWAGE IN THE YARDS, WAS FROM THOSE MOBILES. IT WAS THE

FAULT OF THEIR SYSTEMS IN THE MOBILES. MRS. NEILL STATED THAT THE PROBLEM IN THE PARK HAD BEEN CLEARED UP AND THAT THE TANKS ON THE HILL ARE CHECKED DAILY BY HER HUSBAND, ONE TANK STILL DOES OVER FLOW BUT IT NOW GOES INTO THE EMERGENCY DITCHES.

WALLY JOHNSON, J & V EXCAVATING, STATED THE WORK THAT HE DID IN THE PARK, WAS STRICTLY EMERGENCY WORK AND WAS ALL TEMPORARY. THEY ARE WAITING FOR PLANTS & ASSOCIATES TO GET AN ENGINEERING PLAN READY TO BE CONSIDERED BY THE DEQ FOR REPAIR OF THE SYSTEM. COUNCIL ASKED MR. JOHNSON IF HE FELT THAT THE WORK COULD BE COMPLETED BY 7-15-82, THE DEADLINE GIVEN IN THE DEQ'S LETTER OF REQUIREMENTS. HE STATED THAT IT COULD BE DONE DEPENDING ON WHAT NEEDS TO BE DONE. A DRAINFIELD COULD BE REPAIRED TOMORROW.

JEWEL REMLEY, WOAHINK MOBILE HOME PARK, STATED THAT WHEN SHE MOVED TO THIS AREA, THIS PARK WAS THE ONLY ONE THAT WOULD TAKE CHILDREN. IF THE DEQ FORCES MRS. THOMPSON TO CLOSE THE PARK, IF THE REPAIRS ARE NOT DONE, WHERE WILL THE TENANTS MOVE. NO OTHER PARKS TAKE CHILDREN. MR. LAIRD STATED THAT THIS WOULD BE BETWEEN THE TENANTS AND DEQ.

MAYOR PETERSDORF STATED THAT THERE WAS A NOTE FROM THE DUNES CITY BUILDING INSPECTOR STATING THAT THERE WAS A 5TH WHEEL TRAILER PARKED TO THE NORTH OF THE PARK AND IT WAS HOOKED TO ELECTRICITY AND WATER AND WAS BEING OCCUPIED. THIS WAS DISCUSSED AND THE MANAGER STATED THAT SHE DID NOT KNOW IT WAS HOOKED UP AND THERE WAS TESTIMONY THAT SAID THERE WAS NOT ANYONE OCCUPYING THE TRAILER. MRS. NEILL STATED THAT SHE WOULD CHECK INTO IT.

THE PUBLIC HEARING CLOSED AT 9:53.

MR. LAIRD STATED THAT COUNCIL HAD TO DECIDE WHETHER A NUISANCE DID EXIST BASED ON THE 4 EXHIBITS THAT WERE SUBMITTED INCLUDING THE LOGS FROM LANE COUNTY SANITARIAN ON THE WEEKLY CHECKS. JUDY SMITH, CHAIRMAN OF THE PLANNING COMMISSION GAVE THE PLANNING COMMISSION'S RECOMMENDATION TO TABLE THE REQUEST WUNTIL, 1) THE CHECK FOR \$50 WRITTEN TO THE CITY WAS CLEARED THROUGH THE BANK, AND 2) THAT MR. CHOATE SHOW THE COURTESY OF APPEARING AT A HEARING. THIS MTOION WAS AMENDED TO READ, THAT IF MR. CHOATE DID NOT APPEAR

AT APRIL 8, 1982 CITY COUNCIL MEETING, THAT THE MOBILE HOME BE REMOVED THEREAFTER.

J. SMITH STATED THAT THE CITY RECEIVED INFORMATION ON APRIL 2, 1982 THAT MR. CHOATE HAD LEFT THE AREA AND MOVED TO TEXAS.

MAYOR PETERSDORF STATED THAT HE TALKED TO GREG ANDERSON, WESTERN BANK AND WAS TOLD THAT WESTERN BANK OWNS THE MOBILE HOME ON THE PROPERTY.

## MINUTES OF THE CITY COUNCIL

#### REGULAR MEETING

MAY 19,1982

I. CALL TO ORDER AND ROLL CALL

THE REGULAR MEETING OF THE DUNES CITY COUNCIL WAS CALLED TO ORDER AT 7:30 P.M. ON THE 13TH DAY OF MAY, 1982, BY MAYOR PETERSDORF.

ROLL CALL

PRESENT:

MAYOR PETERSDORF, E. FILLMAN, J. BAUMEISTER, R. SCHMALE, B. PITTS, E. PASSENGER, J. FREELAND, ATTORNEY GERBER, CITY RECORDER B. STOCKING, SECRETARY D. STINGER

II. APPROVAL OF MINUTES OF APRIL 8, 1982

THE MINUTES OF APRIL 8, 1982 HAD A FEW CORRECTIONS. PAGE 1, AT THE BOTTOM OF THE PAGE, A STATEMENT MADE BY MR. PARKER, THE WORDS, "WEST LANE DISPOSAL CUSTOMERS", WERE STRUCK. PAGE 3, THE WORD "ACCEPT" WAS PUT IN THE SECOND PARAGRAPH, PAGE 3 THE WORD "WORKING" WAS MISPELLED.

J. FREELAND MOVED TO ACCEPT THE MINUTES AS CORRECTED. E. PASSENGER SECONDED AND THE MOTION CARRIED.

III. BILLS AGAINST THE CITY

THE BILLS AGAINST THE CITY TOTALED \$1,310.01. E. FILLMAN MOVED TO PAY THE BILLS AGAINST THE CITY. J. FREELAND SECONDED AND THE MOTION CARRIED.

- IV. RECEIPTS OF SESSION \$4,448.05
  - V. CITIZENS INPUT ON UNSCHEDULED ITEMS

JOHN CARLSON, WESTLAKE, WAS PRESENT TO GIVE AN UPDATE ON THE YOUTH HOSTELS PROJECT. THE NATIONAL ASSOCIATION WILL MAKE A LOAN ON THE TIMBER DUNES HOUSE. THERE WILL BE A DECISION JUNE 1 BY THE NRA AND THE COUNTY. THE COUNTY WANTS TO REZONE THE AREA TOURIST COMMERCIAL. ALSO THE HOSTEL WILL BE LOCALLY RUN ALSO THE WORK ON THE HOUSE WILL BE LOCALLY PROVIDED.

PHIL TOUT, EAST LAKE, BROUGHT TO THE COUNCIL'S ATTENTION THAT THERE ARE THINGS BEING DONE IN THE AREA WITH SOLAR AND WIND POWER. HE SUGGESTED THAT DUNES CITY START WORKING ON SOME ORDINANCES TO COVER SOME OF THESE AREAS. MAYBE IF IT WERE DONE AHEAD OF TIME, WHEN SOMETHING COMES UP CONCERNING THIS, THE CITY WILL BE PREPARED. MAYOR PETERSDORF ASKED MR. TOUT IF HE WOULD WORK ON GETTING SOME SAMPLE ORDINANCES ON SOLAR AND WIND POWER FOR THE CITY TO WORK FROM AND OBSERVE.

MR. FURBY, LAKE SHORE TRAILER PARK WAS PRESENT STATING THAT HE HAS TORN DOWN THE BUILDING IN THE TRAILER PARK, THAT WAS HIS RESIDENCE. HE WISHES TO PLACE A DOUBLE WIDE MOBILE ON THAT PART OF THE PROPERTY TO USE AS HIS OFFICE AND HIS RESIDENCE. HE STATED THAT WHEN HE CAME TO APPLY FOR A BUILDING PERMIT TO INSTALL THE MOBILE, THE BUILDING INSPECTOR STATED THAT ACCORDING TO THE COMP PLAN AND THE ZONING ORDINANCE, THIS WOULD BE CONSIDERED AN EXPANSION OF THE MOBILE HOME PARK AND WOULD ENTAIL A LOT OF PROCEDURE. MR. FURBY READ FROM PAGE 66 OF THE ZONING ORDINANCE CONCERNING NON CONFORMING USES.

MR. GERBER STATED THAT THE WAY THAT THE ORDINANCE NOW READS, MR. FURBY WOULD HAVE TO GO THROUGH THE PROCEDURE LISTED IN THE ZONING ORDINANCE FOR EXPANDING A MOBILE HOME PARRK. HE STATED THAT HE DID NOT THINK THAT THE ORDINANCE WAS INTENDED FOR THIS KIND OF SIT-UTION. HE FELT THAT THE ORDINANCE NEEDS TO BE REVIEWED AND POSSIBLY AMENDED. THIS IS SOMETHING THAT NEEDS TO BE TAKEN UP BY THE CCI.

MR. FURBY WENT ON AND EXPLAINED TO THE COUNCIL SOME OF THE PROSPECTIVE PLANS HE HAD FOR THE MOBILE HOME. HE STATED THAT THERE IS A 30' SETBACK FROM THE STATE RIGHT OF WAY SO HE WOULD HAVE TO SET THE MOBILE BACK FROM WHERE THE HOUSE WAS. ALSO HE STATED THAT HE WOULD LIKE TO BUILD AN 8 X10 ROOM ONTO THE FRONT OF THE MOBILE TO USE AS THE OFFICE. THIS WOULD COME CLOSER TO THE HIGHWAY THAN 30' BUT THE AREA ALREADY OTHER MOBILES THAT ARE WITHIN THIS SETBACK SO HE DIDN'T FEEL THAT THIS WOULD BE A PROBLEM.

GERBER STATED THAT THE COUNCIL CAN DECIDE TONIGHT TO ALLOW MR. BURBY TO GO AHEAD AND INSTALL THE MOBILE HOME AND EXTEND THE APPLICATION FOR A VARIANCE 60 DAYS AND BY THEN THE ORDINANCE SHOULD BE CHANGED. HOWEVER, MR. FURBY WILL BE TAKING THE CHANCE THAT THE ORDINANCE WILL NOT PASS AND HE WILL HAVE TO GO AHEAD AND APPLY FOR THE VARIANCE.

THE COUNCIL HELD FURTHER DISCUSSION.

MR. FILLMAN MOVED THAT THE COUNCIL TAKE MR. GERBER'S SUGGESTION AND APPROVE THE ISSUING OF A BUILDING PERMIT TO MR. FURBY, WITH AN EXTENTION OF 60 DAYS ON THE APPLICATION FOR A VARIANCE. J. FREELAND SECONDED AND THE MOTION CARRIED.

> LARS LIND WAS PRESENT AND SUBMITTED A LETTER TO THE CITY COUNCIL CONCERNING A TREE THAT HE WOULD LIKE TO REMOVE ON ALDER DR. HE WAS ASKING FOR THE CITY COUNCIL'S REACTION TO HIS LETTER. MAYOR PETERSDORF STATED THAT THE COUNCIL JUST DID RECEIVE THE LETTER AND THAT THEY WOULD NEED TIME . ALSO THEY WOULD HAVE TO GIVE IT TO THE ROAD COMMITTEE FOR INPUT AND ALSO ACCORDING TO THE EROSION ORDINANCE #59, SECT. 1, PARAGRAPH 4, REQUIRES THAT THE CITY COUNCIL SEND OUT THREE PEOPLE FROM THE EROSION COMMITTEE AND AT THIS TIME WE DO NOT HAVE THREE ON THAT COMMITTEE, ALL OF THE TERMS HAVE EXPIRED. AT THE CITY COUNCIL'S NEXT MEETING THREE PEOPLE WILL BE APPOINTED TO INVESTIGATE THIS. IT COULD BE DECIDED AT THE JULY MEETING.

THANK YOU- B. STOCKING AND DEBBIE STINGER GAVE A LETTER TO THE CITY COUNCIL CONCERNING A THANK YOU FOR THE FLOWERS ON SECRETARY'S DAY.

THANK YOU- THE CITY RECEIVED A THANK YOU FROM THE KIDS FOR THE BUS SHELTER ON ERHART AND CLEAR LAKE RD.

<u>BALLOT MEASURES</u>- B. STOCKING READ THE TITLES OF THE UPCOMING BALLOT MEASURES.

MEARSURE 1- FINANCING MUNICIPAL WATER SYSTEMS
MEASURE 2- STATE BONDS FOR FUNDS TO FINANCE CORRECTIONAL FACILITIES
MEASURE 4- TAXES ON FUELS FOR ROADS

INTERGOVERNMENTAL AGREEMENT - GERBER STATED THAT THE COUNTY HAS WITH-DRAWN THEIR PROPOSAL BECAUSE OF THE FALL IN THEIR REVENUE. THEY MAY COME BACK WITH IT AFTER THEY FIND OUT WHAT WILL HAPPEN WITH THEIR REVENUE.

#### VII. REPORTS

ROAD BIDS- J. FREELAND HAD TWO BIDS ON THE UP COMING ROAD WORK. ONE WAS FOR \$2100 AND THE OTHER WAS FOR \$2168. MR. FREELAND STATED THAT THE BIDS ARE NOT IDENTICAL.

THE COUNCIL HAD A LENGTHY DISCUSSION ON THE ROAD BIDS AND FUTURE ROAD BIDS.

IT SHOULD

BE. THE CITY RECORDER WAS TO GET THE SPEC'S FROM THE ROAD COMMITTEE AND THEN ADVERTISE FOR BIDS.

J. FREELAND ALSO BROUGHT UP THE FACT THAT IN LITTLE WOAHINK HE FOUND THAT THERE IS A LOT OF EROSION GOING ON. B. STOCKING STATED THAT THE COUNCIL HAS A LETTER FROM MR. MORTIER STATING THAT THE ROADS ARE NOT UP TO PAR AND THAT LEMKE HAS BEEN ADVISED TIME AND TIME AGAIN TO GET THEM DONE. GERBER STATED THAT THE CITY HAS THE POWER TO PUT A DEVELOPMENT FREEZE ON MR. LEMKE UNTIL HE GETS THE ROAD COMPLETED. COUNCIL DISCUSSED THIS FURTHER.

IN MR. MORTIER'S LETTER HE GAVE MR. LEMKE UNTIL JUNE 1 TO REPLY AND UNTIL SEPTEMBER 82 TO COMPLETE THE WORK. GERBER STATED THAT THE COUNCIL CAN WAIT UNTIL THE JUNE MEETING TO SEE WHAT LEMKE COMES UP WITH AND THEN DECIDE.

J. FREELAND STATED THAT THE ROAD COMMITTEE NEEDS A CHAIRMAN. COUNCIL DISCUSSED THIS BRIEFLY AND DECIDED TO ADVERTISE FOR THE ROAD CHAIR-MAN.

PLANNING COMMISSION VACANCY- E. PASSENGER MOVED THAT THE CITY COUNCIL ACCEPT THE RECOMMENDATION OF THE PLANNING COMMISSION TO APPOINT SHARON GRESHAM TO THE VACANCY ON THE PLANNING COMMISSION. E. FILLMAN SECONDED AND THE MOTION CARRIED.

BUILDING MAINTAINENCE PROPOSAL - THE COUNCIL HAD BEFORE THEM A PROPOSAL FROM THE STAFF AND THE BUILDING COMMISSIONER LISTING ALL OF THE REPAIRS THAT ARE NEEDED ON THE COMMUNITY CENTER BUILDING. THE COUNCIL DISCUSSED THIS THOROUGHLY AND DECIDED THAT MORE COMPLETE SPEC'S SHOULD BE DRAWN UP AND ALSO THAT THE JOB SHOULD BE ADVERTISED FOR BIDS.

ACTION J. BAUMEISTER MOVED THAT THE CITY ADVERTISE FOR BIDS ON THE PAINT-ING AND MAINTAINENCE AND THAT THE SPEC'S CAN BE PICKED UP AT THE OFFICE. J. FREELAND SECONDED AND THE MOTION CARRIED.

IX. PUBLIC HEARINGS

ARMANDARIZ- CONDITIONAL USE PERMIT 83706 KIECHLE ARM FLORENCE, OREGON 19-12-23-4 TL#200

THE PUBLIC HEARING WAS OPENED AT 8:53.

THE PLANNING COMMISSION REPORT WAS GIVEN TO THE CITY COUNCIL BY THE PLANNING COMMISSION SECRETARY D. STINGER. THE PLANNING COMMISSION RECOMMENDED THAT THE CITY COUNCIL APPROVE THE CONDITIONAL USE PERMIT FOR MR. ARMANDARIZ TO HAVE A HORSE ON THE PROPERTY WITH TWO CONDITIONS, THAT THE ARMANDARIZ'S GET A BACTERIA REPORT ON THE CREEK AND THAT THE HORSE BE KEPT 180' FROM THE CREEK.

THERE WAS NO FURTHER TESTIMONY. THE PUBLIC HEARING CLOSED AT 8:55.

THE CITY COUNCIL DISCUSSED THIS PROPOSAL.

GERBER SUGGESTED THAT ANOTHER CONDITION BE PUT ON THE REQUEST THAT NO HORSE BE KEPT ON THE PROPERTY UNTIL THE RESIDENCE IS OCCUPIED.

ACTION

E. PASSENGER MOVED THAT THE CITY COUNCIL ACCEPT THE PLANNING COMMISSION'S RECOMMENDATION WITH THE TWO CONDITIONS AND THE ADDED THIRD CONDITION. E. FILLMAN SECONDED AND THE MOTION CARRIED.

#### X. UNFINISHED BUSINESS

CHOATE MOBILE HOME- GERBER STATED THAT HE HAD TALKED TO GREG ANDERSON AT WESTERN BANK AND THEY ASKED FOR 60 DAYS TO REMOVE THE CHOATE MOBILE. THIS WAS FROM APRIL 28. THE COUNCIL DISCUSSED THIS ÂT SOME LENGTH.

FILLMAN MOVED THAT THE CITY COUNCIL GRANT WESTERN BANK 60 DAYS FROM APRIL 28, TO SELL AND REMOVE THE MOBILE HOME. E. PASSENGER SECONDED.

AYES: PASSENGER, FILLMAN, SCHMALE, PITTS, BAUMEISTER

NAY: FREELAND

THE MOTION CARRIED.

#### MIKE JOHNSON-LOREN PARKER/ GARBAGE RATES

MR. MIKE JOHNSON WAS PRESENT TO ANSWER SOME OF THE COUNCIL'S QUESTIONS CONCERNING MR. PARKER'S STATEMENTS AT THE LAST CITY COUNCIL MEETING.

MR. GERBER STEPPED DOWN.

MR. JOHNSON STATED THAT HE WOULD ANSWER THE COUNCIL'S QUESTIONS AND THAT MR. PARKER HAD STATED THAT HE WAS GIVING CUSTOMERS INTTHE UNICORPORATED AREAS A BETTER RATE THAN THOSE IN THE INCORPORATED AREAS. MR. JOHNSON STATED THAT HE HAS ASKED IN THE PAST AND IS ASKING AGAIN FOR THE COUNCIL TO APPOINT A COMMITTEE TO COME AND LOOK AT HIS BOOKS AND CHECK HIS RATES AND HIS COSTS.

THE COUNCIL DISCUSSED AT LENGTH THE CONCEPT OF THE FRANCHISE. PASSENGER STATED THAT THE CITY CAN NOT DICTATE TO MR. JOHNSON WHAT HIS RATES CAN BE, WE HAVE A CONTRACT TO HONOR AND THE CITY SIGNED WITH MR. JOHNSON IN GOOD FAITH. MR. PARKER KNEW WHEN HE CAME TO THIS AREA THAT MR. JOHNSON HAD A FRANCHISE WITH DUNES CITY AND WITH FLORENCE.

MAYOR PETERSDORF STATED THAT HE WOULD GET A COMMITTEE TOGETHER AND GET TOGETHER WITH MR. JOHNSON TO LOOK AT HIS FIGURES. HE WOULD CONTACT MR. JOHNSON AT THAT TIME.

LOREN PARKER, WEST LANE DISPOSAL WAS PRESENT TO GIVE TESTIMONY. HE STATED THAT IN THE PAST MONTH HE HAS OFFERED HIS BUSINESS TO MR. JOHNSON BUT NOT BECAUSE HE IS NOT MAKING IT. HE WAS OFFERED PART OF J & V EXCAVATING AND HE FIGURED IF HE TOOK IT, MR. JOHNSON WOULD BE THE ONLY ONE IN THIS AREA THAT WOULD BE INTERESTED IN THE GARBAGE BUSINESS. HE DID NOT TAKE THE J & V OFFER. HE ALSO GAVE A BRIEF DISCRIPTION ON HOW HE RUNS HIS BUSINESS COMPARED TO MR. JOHNSON'S

BUSINESS. HE STATED THAT THE CITY COUNCIL CAN DO SOMETHING ABOUT THIS SITUATION BY STANDING ON THEIR OUR TWO FEET AND DOING SOMETHING AND THE CITY WOULD NOT BE IN VIOLATION OF ANY AGREEMENT. HE STATED THAT MR. JOHNSON CAN NOT COMPETE WITH HIM, IF HE USES COST AS A FACTOR. THIS IS HOW THINGS ARE. THE GUY THAT CAN DO IT THE CHEAP-EST SHOULD GET THE JOB.

WOAHINK MOBILE HOME PARK - PASSENGER STATED THAT THERE WAS IN THE PACKET A LETTER FROM MRS. NEIL THAT SHE WILL BE RENTING 4 VACANT SPOTS IN THE PARK. SHE FELT THAT THIS WOULD PUT MORE OF A LOAD ON THE FAILING SYSTEM. B. STOCKING STATED THAT THE SANITARIAN GAVE PERMISSION FOR RENTING THESE SPOTS BECAUSE THEY HAVE JUST BEEN VACATED. NO ADDITIONAL SPOTS ARE BEING FILLED.

LEMKE NEGOTIATIONS - GERBER STATED THAT THE NEGOTIATIONS HAVE BEEN TURNED DOWN BY MR. LEMKE. THIS SETTLEMENTS WAS SENT TO THE CITY BY MR. LEMKE'S ATTORNEY AND MR. ROBBINS. COUNCIL DISCUSSED THIS THOROUGHLY.

FILLMAN MOVED THAT THE CITY COUNCIL INSTRUCT OUR ATTORNEY TO GO ACTION AHEAD WITH THE DEFENDING OR PROPER PROCEEDINGS AGAINST MR. LEMKE. E. PASSENGER SECONDED AND THE MOTION CARRIED.

> LEMKE PROPERTY - GERBER STATED THAT HE WAS CONTACTED BY A LOCAL REALTOR ABOUT A PIECE OF LEMKE PROPERTY THAT A 3RD PARTY HAS BEEN BUYING FROM MR. LEMKE FOR A NUMBER OF YEARS. THEY NOW WANT TO MAKE THE PAY OFF. THE CITY HAS THE ORDINANCE FREEZING DEVELOPMENT ON ANY LEMKE PROPERTY UNTIL THE LIEN IS SETTLED WITH THE CITY. COUNCIL DISCUSSED THE POSSIBILITY OF EXCLUDING THIS PARTY FROM THE FREEZE SINCE THE DEAL WAS MADE BEFORE THE ORDINANCE OR THE VIOLATION OCCURED.

J. FREELAND MOVED THAT THE CITY COUNCIL EXLUDE THE THIRD PARTY ACTION IN THE SALE TO BE EXCLUDED FROM ANY LIENS OR FREEZES ON ANY LEMKE PROPERTY. E. PASSENGER SECONDED AND THE MOTION CARRIED.

> THE COUNCIL DISCUSSED THIS FURTHER AND ASKED ATTORNEY GERBER THE NAME OF THE PERSON THAT IS THE THIRD PARTY IN THIS DEAL SO THAT THE CITY RECORDER WILL BE INFORMED. HE STATED THAT HE DID NOT KNOW THE NAME BUT WOULD FIND OUT. HE WOULD GET BACK TO THE CITY RECORDER.

ALSO GERBER STATED THAT HE HAS FOUND OUT FROM LCDC THAT THEY OK THE USE OF THE MAINTAINENCE GRANT MONEY TO PAY FOR THE EXPENSES IN THE LEMKE DEALINGS.

#### XI. NEW BUSINESS

BUDGET 82-83- MAYOR PETERSDORF STATED THAT THE CITY COUNCIL HAS IN THEIR PACKETS THE LIST OF BUDGET MEETINGS TO BE HELD. ALL MEMBERS ARE TO COME TO THOSE MEETINGS. THE FIRST MEETING WILL BE ON MAY 27 ON REVENUE SHARING.

PROVISIONS FOR THE LANDING OF SEA PLANES AND THE STATE HAS NO RE-GULATIONS FOR SEA PLANES EITHER.

ALSO THE SEA PLANE RIDES WANT TO PUT UP A LARGER SIGN. THE COMP PLAN OR ZONING ORDINANCE HAS NO PROVISION FOR THIS EITHER.

THE CCI COMMITTEE WILL BE ACTIVATED AND HOLD SOME METTINGS ON BOTH OF THESE ISSUES. GARY DARNELL SHOULD BE NOTIFIED TO ATTTEND THOSE MEETINGS. THE COMP PLAN NEEDS TO BE REVISED.

MAYOR PETERSDORF STATED THAT JIM BAUMIESTER IS THE HEAD OF THE CCI AND HE WILL ARRANGE SOME MEETINGS.

#### WESTLAKE TAVERN LIQUOR RENEWAL-DARLINGS RESORT LIQUORE RENEWAL

CUTTING CABLE AND THE TOWN WAS OUT OF CABLE FOR DAYS BECAUSE OF A FIGHT BETWEEN THE CABLE COMPANY AND THE CONSTRUCTION COMPANY ON WHO SHOULD FIX THE CABLE. MR. BAUMEISTER STATED THAT HE DID NOT FEEL THAT OUR FRANCHISE ORDINANCE HAS US COVERED IN THIS KIND OF SITUATION. GERBER STATED THAT HE WOULD LOOK INTO THIS AND GET BACK TO THE COUNCIL.

#### I. CALL TO ORDER AND ROLL CALL

THE REGULAR MEETING OF THE DUNES CITY COUNCIL WAS CALLED TO ORDER BY MAYOR PETERSDORF AT 7:30 P.M. ON THE 10TH DAY OF JUNE, 1982.

ROLL CALL

PRESENT:

MAYOR PETERSDORF, E. FILLMAN, J. FREELAND, R. SCHMALE, J. BAUMEISTER, E. PASSENGER, B. PITTS, ATTORNEY GERBER, CITY RECORDER B. STOCKING, AND SECRETARY D. STINGER.

THERE WERE 10 CITIZENS PRESENT.

#### II. APPROVAL OF MINUTES OF MAY 13, 1982

E. FILLMAN MOVED THAT THE MINUTES OF MAY 13, 1982 BE APPROVED WITH CORRECTIONS OF MISPELLINGS AND TYPING ERRORS. J. FREELAND SECONDED AND THE MOTION CARRIED.

#### III. BILLS AGAINST THE CITY

E. PASSENGER MOVED THAT THE BILLS AGAINST THE CITY TOTALING \$874.77 BE PAID. J. BAUMEISTER SECONDED AND THE MOTION CARRIED.

- IV. RECEIPTS OF SESSION \$3,684.49.
- V. CITIZENS INPUT ON UNSCHEDULED ITEMS

HARRY MCLAIN, GREEN GATE RD., DUNES CITY, WAS PRESENT TO GIVE THE COUNCIL A BRIEF PRESENTATION ON A GROUP OF BUSINESSMEN THAT ARE WORKING ON ADVERTISING THE FLORENCE AND SURROUNDING AREAS AND WHAT THEY HAVE TO OFFER. HE STATED THAT WITH THEIR PRESENTATION TO THE CITY OF FLORENCE, THEY ASKED FOR 50% OF THE ROOM TAX REVENUE. HE SPOKE OF THE RETIREMENT COMMUNITY IN OUR AREA AND HOW THEY HAVE KEPT US GOING THROUGH THESE HARD TIMES.

MR. HOD JOHNSON, FLORENCE, ALSO WITH THIS SAME GROUP, SPOKE ON HOW THE MONEY IS SPENT ON ADVERTISING. HE PRESENTED CHARTS AND GAVE EXPLANATIONS. HE ALSO STATED THAT THE GROUP WILL BE MEETING JUNE 17, 9:30 A.M. AT WINDWARD INN. THEY WILL BE HOLDING TWO MEETINGS MONTHLY THROUGH OUT THE SUMMER. HE STATED THAT IF DUNES CITY DECIDED TO GIVE 50 % OF THEIR ROOM TAX, THEY WOULD DEFINATELY HAVE INPUT AS FAR AS THE ADVERTISING.

ALSO MR. ACTION J. FREELAND MOVED THAT THE CITY HAVE A NEW ROOF PUT ON THE BUILDING. E. FILLMAN SECONDED AND THE MOTION CARRIED.

THE SECRETARY RETURNED AND STATED THAT SHE COULD NOT GET A HOLD OF FRANK HAWKINS, BUT THAT MR. CIRCLE STATED THAT HE WOULD USE OLYMPIC STAIN AND CARL RAMSEY STATED HE WOULD USE TOP QUALITY PAINT, WHATEVER THE CITY WOULD LIKE HIM TO USE.

- R. SCHMALE MOVED THAT THE CITY AWARD THE ROOFING BID TO CARL RAMSEY, AS LOW BIDDER. J. FREELAND SECONDED AND THE MOTION CARRIED.
- ACTION R. SCHMALE MOVED THAT THE CITY AWARD THE PAINTING BID THE KEITH CIRCLE, AS LOW BIDDER. B. PITTS SECONDED AND THE MOTION CARRIED.

#### ROAD COMMITTEE

J. FREELAND STATED THAT THEY HAD BEEN NO RESPONSE TO THE ROAD CHAIRMAN JOB OPENING. ALSO FREELAND STATED THAT VAKE SAMPSON OF THE ROAD COMMITTEE WAS SUBMITTING THE INFORMATION AGAIN THIS YEAR REQUESTING THE FEDERAL ROAD GRANT.

#### CCI REPORT

- J. BAUMEISTER GAVE A BRIEF REPORT ON THE CCI MEETINGS HELD ON MAY 19 AND JUNE 9, 1982. HE STATED THAT THE ISSUES DISCUSSED WERE ORDINANCES CONCERNING SIGNS IN COMMERCIAL ZONES, REMOVAL OF STICK BUILT STRUCTURES AND REPLACING WITH MOBILE HOME TYPE STRUCTURES IN A MOBILE HOME PARK, AND AN ORDINANCE CONCERNING SEA PLANES IN DUNES CITY. HE STATED THAT MR. GERBER WOULD BE DRAFTING THE RESULTS OF THOSE MEETINGS INTO ORDINANCES AND THAT THEY WOULD HAVE TO GO TO THE PLANNING COMMISSION FOR INPUT AT THEIR REGULAR JUNE MEETING.
- MR. BUTCH PATTERSON, WOAHINK DR., DUNES CITY, OPERATOR OF THE SEA PLANE RIDES IN DUNES CITY, ASKED THE COUNCIL WHAT THE ORD-INANCE CONCERNING SEA PLANES WOULD MEAN TO HIM. THE COUNCIL STATED THAT HE WAS EXCLUDED FROM THIS ORDINANCE SINCE HIS OPERATION WAS GRANDFATHER. MR. PATTERSON STATED THAT THIS OPERATION

IS MUCH MORE THAT SEA PLANE RIDES. THIS AREA IS A DESIGNATED SEA PLANE PORT. IT IS THE ONLY AREA THAT PLANES CAN LAND AND GET FUEL AND HAVE SIMPLE REPAIRS DONE. AS HE UNDERSTOOD THE DRAFT ORDINANCE, THIS WOULD PROHIBIT THIS. GERBER VERIFIED THIS. HE STATED THAT THE COMMITTEE WAS NOT AWARE OF THE FACT THAT ALL OF THIS WENT ON. IT WAS NOT DISCUSSED AT CCI. GERBER SUGGESTED THAT MR. PATTERSON APPEAR AT THE JUNE 16 MEETING OF THE PLANNING COMMISSION AND DISCUSS THIS WITH THEM SINCE THEY WILL BE WORKING ON THE ORDINANCE.

MR. GERBER GAVE THE COUNCIL A MEMO CONCERNING THE REMOVAL OF STICK TYPE STRUCTURES AND REPLACING THEM WITH MOBILE HOME TYPE STRUCTURES IN A MOBILE HOME PARK.

#### X. UNFINISHED BUSINESS

<u>LEMKE LIEN SEARCH</u>- MR. GERBER HAD A MEMO IN THE COUNCIL'S PACKET CONCERNING THIS ISSUE. THERE WAS NO DISCUSSION.

#### APPOINTMENT OF SOIL EROSION COMMITTEE

MAYOR PETERSDORF ASKED COUNCIL FOR NAMES OF THREE PEOPLE TO PUT ON THE EROSION COMMITTEE. E. PASSENGER GAVE THE NAME OF BILL BECK AND E. FILLMAN GAVE THE NAME OF HARLON STRENKE. NEITHER OF THESE PEOPLE HAD BEEN CONTACTED AS TO WHETHER THEY WOULD ACCEPT THE POSITION YET. THERE WAS SOME DICUSSION ON PUTTING THE PLANNING COMMISSION ONTHIS PRO-TEM UNTIL ANOTHER PERSON COULD BE APPOINTED. THE SE TERMS WILL RUN THREE YEARS. MAYOR PETERSDORF DISCUSSED WITH DUKE WELLS , WHO WAS IN THE AUDIENCE, WHETHER HE WOULD BE INTERESTED IN A POSITION ON THE EROSION COMMITTEE. THE REASON THE EROSION COMMITTEE NEEDS TO BE ACTIVATED IS BECAUSE MR. LARS LIND ON ALDER DR. , HAS TWO TREES THAT ARE IN THE CITY RIGHT OF WAY. THAT HE WOULD LIKE TO REMOVE AND THIS TAKES A SITE REVIEW AND REPORT BY THE EROSION COMMITTEE. MR. WELLS AGREED TO BE ON THE COMMITTEE. MAYOR PETERSDORF STATED THAT THE CITY WOULD SEND HIM A COPY OF THE EROSION ORDINANCE AND INFORMATION ON THIS ISSUE.

#### EPW-2

MR. WILKES, EUGENE, OREGON, WAS PRESENT REPRESENTING EPW-2. EPW-2 WAS ASKING FOR A RE-GRANTING OF THEIR PRELIMINARY APPROVAL OF THEIR PLANNED UNIT DEVELOPEMENT. AFTER SOME DISCUSSION IT WAS FOUND THAT THEIR PUD EXPIRED ON MAY 14, 1982. ALSO THERE WAS SOME DISCUSSION ON THE SURVEY THAT EPW-2 SUBMITTED TO THE CITY, CONCERNING THE INCREASE FROM 77 ACRES TO 82 ACRES. MR. WILKES STATED THAT THE COUNCIL HAD IN FRONT OF THEM ANOTHER SURVEY. ALSO THE COUNCIL HAD THE AERIAL PHOTO FROM EPW-2. IT WAS FELT THAT THIS WAS NOT A RELIABLE SURVEY. IT WAS READ FROM THE SEPTEMBER 10, 1981 COUNCIL MINUTES THAT ALL THE COUNCIL ASKED FOR WAS A SECOND OPINION ON THE SURVEY.

COUNCIL DISCUSSED THE RE-GRANTING OF THE PUD FURTHER. MR. WILKES MADE A COMMENT THAT THEY WOULD HAVE TO HAVE ACCESS FROM HWY 101 AFTER ALL. E. PASSENGER STATED THAT THIS WAS NOT ACCEPTABLE PER

THE ORIGINAL 35 CONDITIONS SET ON THE PRELIMINARY APPROVAL. MAYOR PETERSDORF STATED THAT THIS IS NOT WHAT WE ARE CONCERNED WITH TONIGHT. THIS WILL COME UP LATER.

ACTION E. FILLMAN MOVED TO REINSTATED EPW-2 PRELIMINARY APPROVAL WITH THE SAME CONDITIONS AND TERMS.

THE CITY RECORDER BROUGHT UP THE FACT THAT THE ZONING ORDINANCE STATED THAT FOR A RE-GRANTING OF THE PUD, IT MUST BE DONE WITH A RECOMMENDATION FROM THE PLANNING COMMISSION.

FILLMAN WITHDREW HIS MOTION. MAYOR PETERSDORF STATED THAT THIS WOULD GO BEFORE THE PLANNING COMMISSION AT THEIR REGULAR JUNE MEETING.

WATT'S MOBILE - COUNCIL BROUGHT UP THE QUESTION ON WHAT THE BUILDING GOING ON OVER AT THE WATT'S MOBILE HOME IS ALL ABOUT. B. STOCKING STATED THAT THE BUILDING INSPECTOR PUT A STOP WORK ORDER ON THE BUILDING UNTIL HE COULD SEE SOME PLANS. HE HAD GIVEN THEM A PERMIT TO BUILD A PORCH OR DECK, BUT THIS BUILDING WAS ENCLOSED. THEY HAVE SUBMITTED PLANS AND ARE BEING CONSIDERED FOR A BUILDING PERMIT. AS FAR AS THE MOBILE BEING SKIRTED, THE BUILDING INSPECTOR STATED THAT THIS WAS NOT A STATE STANDARD. IT DID NOT HAVE TO BE SKIRTED.

#### XI. NEW BUSINESS

#### LAROCCO PROPERTY ENCROACHMENT

VINCE LAROCCO, 83397 PARKWAY DR., DUNES CITY, WAS PRESENT AND HAD SUBMITTED A LETTER TO THE COUNCIL CONCERNING THE CITY'S RIGHT OF WAY, BUCKSKIN BOB, ENCROACHING ON HIS PROPERTY ALONG THAT ROAD, BY 10'. HE WAS STATING THAT HE WAS PAYING TAXES ON THIS PROPERTY AND HAD TALKED TO MR. GERBER ABOUT THE SITUATION. MR. The problem faced by Mr. Furby has brought to our attention the fact that stickbuilt structures in mobile home parks are presenting us with some problems. It would be my suggestion that we exclude the replacement of a stickbuilt home, or similar structure, with a mobile home from the requirements of Section 7(I).

The language below would accomplish this, and I tender this proposal to the city for its consideration. I would propose the following language:

## SECTION 7(I)(a)(3):

The replacement of any existing stickbuilt structure situated within a mobile home or a travel trailer park, with a mobile home, shall not be subject to the requirements of Section 7(I)(a). Section 7(I)(a)(3) is not intended to excuse a person who would replace such a structure with a mobile home from the normal permits which must be obtained, and, in addition, the project must meet the standards set forth in paragraph (b) immediately below.

The City Council should review the above suggestion, and determine if the proposal is a sound idea, and if the concept is appropriate, the City Council should also review the specific language of the proposed ordinance amendment.

MR. TRACEWELL GAVE A SHORT PRESENTATION ON SOME OF THE OTHER THINGS THAT A NEIGHBORHOOD WATCH GROUP DOES.

MR. BENICASSA, GAVE A BRIEF OUTLINE OF WHAT HIS GROUP DOES. ALSO HE PRESENTED TO THE COUNCIL A SIGN THAT INDICATES THAT A CERTAIN NEIGHBORHOOD IS UNDER THE NEIGHBORHOOD WATCH PROGRAM.

MR. TRACEWELL ANNOUNCED THAT THERE WOULD BE A COUNTY REPRESENTATIVE WHO COORDINATES THE WATCH GROUPS AT THE COUNTY ANNEX, JUSTICE COURT ROOM, ON JULY 20, 1982, AT 7:30.

MAYOR PETERSDORF STATED THAT HE FELT THAT THE CITY SHOULD RUN AN AD IN THE PAPER BEFORE THE JULY 20TH MEETING ENCOURAGING DUNES CITY RESIDENTS TO ATTEND THIS NEIGHBORHOOD WATCH MEETING. ALSO POSSIBLY AFTER THE JULY 20 TH MEETING THE CITY COULD RUN AN AD ASKING CITIZENS TO ATTEND A HEARING BEFORE THE CITY COUNCIL FOR INPUT ON THIS SUBJECT.

THE CITY RECORDER WAS INSTRUCTED TO DO SO.

LEMKE - ATTORNEY GERBER STATED THAT A FEW WEEKS AGO SOME PEOPLE CAME INTO THE CITY AND ASKED ABOUT A PIECE OF PROPERTY THAT BELONGED TO MR. LEMKE. THEY WERE CONSIDERING BUYING THE PARCEL BUT WANTED TO KNOW ABOUT BUILDING PERMITS ETC. THE CITY TOLD THEM THAT WE HAD A DEVELOPEMENT FREEZE ON ANY LEMKE PROPERTY AND A BUILDING PERMIT WOULD NOT BE ISSUED. MR. LEMKE CLAIMED THAT THIS PROPERTY WAS NOT IN HIS NAME. THE TITLE COMPANY SENT A LIEN SEARCH TO THE CITY AND THE CITY INFORMED THEM THAT IF THE PROPERTY WAS IN LEMKE'S NAME ANYTIME AFTER JUNE 12, 1982, THE CITY COULD DENY A BUILDING PERMIT. THROUGH RESEARCH, IT SEEMS THAT THE PROPERTY WAS NOT IN LEMKE'S NAME AT THAT TIME, SO IT APPEARS THAT THIS PROPERTY WOULD NOT BE LIABLE UNDER THE DEVELOPMENT FREEZE.

#### BUDGET HEARING

MAYOR PETERSDORF INTERUPTED THE COUNCIL TO CONCLUDE THE BUDGET HEARING. IT WAS CLOSED AT 8:30 P.M.

MAYOR PETERSDORF READ INTO THE RECORD THE RESOLUTION TO ADOPT THE 1982-83 CITY BUDGET.

E. PASSENGER MOVED TO ADOPT RESOLUTION 7-8-82 ACCEPTING THE 1982-83 DUNES CITY BUDGET. J. FREELAND SECONDED AND THE MOTION CARRIED.

#### VIII. REPORTS

BUILDING MAINENANCE- ED FILLMAN STATED THAT THE OUTSIDE OF THE BUILDING HAS BEEN PAINTED AND THE ROOF HAS BEEN PUT ON. ALSO THE CITY HAD NEW GUTTERS AND DOWN SPOUTS PUT ON THE BUILDING. THE INTERIOR PAINTING IS NOW BEING DONE.

DRAFT ORDINANCES- PLANNING COMMISSION REPORT- D. STINGER GAVE THE RECOMMENDATIONS OF THE PLANNING COMMISSION TO THE CITY COUNCIL. THE PLANNING COMMISSION RECOMMENDED TO THE CITY COUNCIL APPROVAL OF THE ORDINANCE CONCERNING REMOVAL OF STICK STRUCTURES IN A MOBILE HOME PARK. THE PLANNING COMMISSION ALSO RECOMMENDED TO THE CITY COUNCIL THE APPROVAL OF THE SIGN ORDINANCE WITH CHANGES AS DRAFTED

WITH THE ADDITION OF A PURPOSES CLAUSE. D. STINGER STATED THAT THE PLANNING COMMISSION DID NOT CONSIDER A SEA PLANES ORDINANCE, SINCE MR. GERBER IS STILL RESEARCHING THE ISSUE.

MR. FILLMAN STATED THAT IN THE PLANNING COMMISSION MINUTES OF JUNE 16, 1982, PAGE 2 IT READS "SILTCOOS MOBILE HOME PARK" THIS SHOULD BE "LAKESHORE".

THE COUNCIL DISCUSSED THESE ORDINANCES BRIEFLY.

- ACTION E. FILLMAN MOVED THAT THE CITY COUNCIL PUT THE SIGN ORDINANCE ON THE DOCKET FOR THE AUGUST 12 MEETING. J. BAUMEISTER SECONDED AND THE MOTION CARRIED.
- ACTION E. FILLMAN MOVED THAT THE CITY COUNCIL PUT THE MOBILE HOME PARK ORDINANCE ON THE DOCKET FOR THE AUGUST 12, MEETING. BAUMEISTER SECONDED.

SOME OF THE COUNCIL MEMBERS STATED THAT THEY DID NOT HAVE COPIES OF THIS ORDINANCE. GERBER STATED THAT THE COUNCIL MEMBERS SHOULD HAVE THIS ORDINANCE AHEAD OF THE AUGUST MEETING TO STUDY FOR ANY CHANGES.

FILLMAN WITHDREW HIS MOTION.

MAYOR PETERSDORF STATED THAT THIS WOULD BE PUT ON THE AUGUST MEETING FOR CONSIDERATION.

#### EROSION COMMITTEE REPORT RE: ALDER DRIVE TREES

DUKE WELLS, WOAHINK DR., DUNES CITY WAS PRESENT AS THE CHAIRMAN OF THE EROSION COMMITTEE. HE GAVE A BRIEF DESCRIPTION OF HIS EXPERIENCE WITH TREES AND LAND WORK. HE STATED THAT HE AND HIS COMMITTEE, CALVIN AND DEBBIE STINGER, LOOKED OVER THE AREA. IT WAS THE FEELING OF THE COMMITTEE THAT THE TREES COULD NOT BE REMOVED, ALONG WITH THE STUMPS, WITHOUT CAUSING EROSIION OF THE HILLSIDE. IT WAS THE RECOMMENDATION OF THE COMMITTEE THAT THE TREES NOT BE MOVED. MR. WELLS STATED THAT MR. LIND COULD HAVE A UTILITY POLE ON THE OTHERSIDE OF THE ROAD MOVED A FEW FEEL AND HAVE BETTER ACCESS ON ALDER DR.

HARRY MCLAIN, GREEN GATE, DUNES CITY, WAS PRESENT REPRESENTING MR. LIND. HE STATED THAT MR. LIND JUST WANTED TO REMOVED THE LOWER TREE AND NOT THE STUMP. HE WAS GOING TO HAVE THE STUMP CUT BACK FLUSH. ALSO HE STATED THAT MR. LIND WAS WILLING TO PUT UP A RETAINING WALL TO HOLD BACK THE HILLSIDE. MR. MCLAIN STATED THAT THE REASON MR. LIND NEEDS THE ROAD WIDENED IS BECAUSE AT THE POINT WHERE THE TREES ARE LOCATED IT IS ONLY 10' WIDE AND HE CAN NOT GET AN RV THROUGH THERE.

STEVE REITERMAN, HUCKLEBERRY LN, DUNES CITY, WAS PRESENT TO TESTIFY AGAINST THE REMOVAL OF THOSE TREES. HE STATED THAT THE TREES ARE DIRECTLY IN FRONT OF HIS HOUSE AND THAT HE DID NOT WANT THEM MOVED

MOSTLY BECAUSE OF THE EROSION THAT WOULD TAKE PLACE AND THE HILLSIDE IS VERY CLOSE TO HIS HOME. HE STATED THAT THESE TREES ARE VERY OLD AND THE POSSIBILITY OF THOSE ROOTS BEING VERY ENTWINED IN THE HILLSIDE, IS GREAT. HE FELT THAT ONE TREE COULD NOT BE REMOVED WITHOUT KILLING THE OTHER TREE. HE ALSO STATED THAT MR. LIND IS ONLY A PART TIME RESIDENT AND THAT HE IS A FULL TIME RESIDENT AND FEELS THAT THERE IS NOT REASON FOR THOSE TREES TO BE REMOVED. HE FELT THAT SOME OF THE OTHER TREES COULD BE TRIMMED AND GAVE A FEW FEET. HE DEFINATELY DID NOT WANT THE TREES MOVED.

AFTER LENGTHLY DISCUSSION, THE MAYOR RECOMMENDED TO THE CITY COUNCIL THAT THIS ISSUE BE TABLED UNTIL THE AUGUST CITY COUNCIL MEETING SO MR. LIND COULD BE HERE TO ANSWER QUESTIONS.

#### ROAD BIDS

MAYOR PETERSDORF GAVE THE CITY RECORDER THREE SEALED BIDS FOR THE CITY'S ROAD WORK. THEY WERE FROM, ART CONING CONSTRUCTION, RAY WELLS CONSTRUCTION AND J & V EXCAVATING.

THE CITY RECORDER STATED THAT THE COUNCIL HAD IN FRONT OF THEM A COPY OF THE SPEC'S THAT EACH OF THESE COMPANIES MADE THEIR BIDS FROM. THE BIDS WERE OPENED.

ART CONING -----\$ 3,894.90

J & V EXCAVATING-----\$ 3,320.50

RAY WELLS-----\$ 2,659.50

THE COUNCIL DISCUSSED THE BIDS. THE CITY RECORDER STATED THAT ON THE BIDS THERE WAS SOME DIFFERENCE IN THE CULVERT LENGTHS AND THAT ON THE RAY WELLS BID, "WRIGHT ROAD" WAS LEFT OFF. HOWEVER, EACH OF THE BIDDERS RECEIVED THE SAME SPEC'S.

COUNCIL DECIDED THAT THE CITY WOULD START WITH THE LOW BIDDER. MAKE SURE THAT THEIR BID INCLUDES ALL OF WHAT IS ON THE SPEC'S. RAY WELLS IS TO BE CONTACTED AND QUESTIONED ON THEIR DIFFERENCES. IF THEY FEEL THAT THEY CAN NOT DO THE WORK FOR WHAT THEY BID, THEN GO TO THE NEXT LOWEST BIDDER.

- ION E. PASSENGER MOVED THAT THE CITY ACCEPT THE RAY WELLS BID FOR \$2,659.50, AS PER THE CITY SPEC'S. R. SCHMALE SECONDED AND THE MOTION CARRIED.
  - E. PASSENGER MOVED THAT IF RAY WELLS REFUSES THE BID, THE MAYOR HAS DIRECTION TO ACCEPT THE NEXT LWEST BIDDER. J. BAUMEISTER SECONDED AND THE MOTION CARRIED.

MAYOR PETERSDORF STATED THAT THE PRESS WAS NOT AT THIS MEETING BECAUSE THEY HAVE A NEW MANAGER THAT IS MAKING CUTBACKS AND THEY ARE CUTTING THE REPORTERS HOURS. THEY ARE GOING TO TRY TO MAKE JUST THE REAL IMPORTANT MEETINGS.

#### ROAD COMMISSIONERS REPORT

J. FREELAND GAVE A BRIEF REPORT ON THE BUCKSKIN BOB-LAROCCO ISSUE. HE STATED THAT HE TALKED TO BERNIE LAFORGE, HERB SAUTER AND GENE COCKERAM ABOUT BUCKSKIN BOB.

HE STATED THAT BERNIE LAFORGE SAID THAT THE ROAD USED TO BE A 10' ROAD. MR. COCKERAM ALSO STATED THAT THE ROAD USED TO BE MUCH NARROWER AND ABOUT FIVE YEARS AGO WAS WIDENED WITH THE IMPROVEMENTS. HERB SAUTER SAID THAT THE ROAD HAS ALWAYS BEEN ABOUT 15' WIDE.

MR. GERBER STATED THAT HE HAS BEEN TRYING TO GET AHOLD OF THE COUNTY ASSESSOR BUT HAS NOT BEEN ABLE TOO. HE WAS GOING TO ASK HIM ABOUT GETTING SOME TAX RELIEF FOR MR. LAROCCO.

COUNCIL DISCUSSED THIS WITH MR. LAROCCO WHO WAS PRESENT. HE STATED THAT HE IS PAYING FOR 10' OF PROPERTY THAT IS IN THE MIDDLE OF THE ROAD.

MR. GERBER STATED THAT HE WOULD TALKE TO THE COUNTY ASSESSOR TOMORROW WHEN HE WAS IN EUGENE AND HE WOULD GET BACK TO THE COUNCIL.

GREATER SIUSLAW ECONOMIC FORUM REPORT

E. FILLMAN GAVE A BRIEF REPORT ON THIS COMMITTEE. HE STATED THAT
THEY ARE JUST NOW FINISHING THEIR BY-LAWS. THE ONLY THING HE WANTED
TO BRING UP WAS THAT ONE OF THE BY-LAWS WAS THAT WHEN A REPRESENTATIVE
IS SENT TO A MEETING, AN ALTERNATE SHOULD ALWAYS BE SENT ALSO TO KEEP
CONTINUITY.

#### X. PUBLIC HEARING

EPW-2 SOUTH SHORE WOAHINK 19-12-27-1 RE-GRANTING OF THE PUD

THE PUBLIC HEARING WAS OPENED AT 9:59 P.M.

THERE WAS NO TESTIMONY TAKEN.

THE PUBLIC HEARING WAS CLOSED AT 10:00 P.M.

THE COUNCIL HAD BEFORE THEM THE RECOMMENDATION OF THE PLANNING COMMISSION WHICH WAS THAT THEY RECOMMENDED TO THE COUNCIL THAT THE EXTENSION BE GRANTED IF ALL CONDITIONS OF THE PREVIOUS P.U.D. ARE MET.

#### VI. UNFINISHED BUSINESS

Woahink Mobile Home Resort.

Attorney Hilborn reported that the July 15, 1982 deadline has passed and that no excavation or renovation of the SDS system has started.

Ann Bunnenberg, 259 E. 5th, Eugene, OR., stated that we are behind schedule. Finance has been a problem as they needed to assure the bank of payment. Loan papers are drawn and could start construction at the end of the following week. They have been working with the contract installer and he has approved the contract of \$67,590.00, the bid to install the system. The preconstruction meeting has been held with D.E.Q., Lane County officials, including the installer. Repaired septic system is now functioning. Part of the time delay is due to the recording of the morgage. There is no problem with the water system as it has been checked by State Officials. The contract calls for a forty day time for installation, but could be done in thirty days.

- C. A. Garska, 8370 Hwy. 101, Dunes City, stated he will withdraw his complaint if the work is started by September 15, 1982.
- J. Baumeister asked if the present system will operate during replacement of the new system. Attorney Bunnenberg replied she thought it would.
- E. Passenger stated that D.E.Q. would close the park if the system is not finished.
- J. Freeland moved to table any action until the September meeting. This motion was seconded by E. Passenger. Motion carried by unanimous vote.
- VII. NEW BUSINESS- Initiative Petition Attorney Jim Hilborn represening Dunes City

Attorney feels that part of the problem is this is the first petition filed with the City. Some directives are needed.

Mayor Petersdorf asked if any action was needed by the Council on the petition. Attorney Hilborn, presented options to the Council, they can reject the petition, take no action and/or educate the people on the existing franchise.

Mayor Petersdorf was concerned with the legal ramifications, who is libel, the City or the petition signors?

Attorney Hilborn feels the City could be as they have a valid contract with Siuslaw Sanitary Service.

R. Schmale feels the books should be checked, as Mike Johnson has stated before the Council that no profit had been made.

Much discussion on the proceedure of the initiative petition, as to election dates and filing time. Also concern if Dunes City Initiative and Referendum Ordinance no. 36 has precedence over the Oregon State Ordinance on dates, time and ballot title form.

- 4. Invitation to attend a meeting from Oregon Parks and Recreation regarding beach closure. Meeting to be in Reedsport, September 16, 1982 at 1 p.m.
  - E. Passenger and J. Freeland will attend.
- 5. Ron Gerber reported on a letter from Oregon Division of State Lands regarding estuaries. This does not impact Dunes City. Council concurs. No action taken.
- 6. Attorney Gerber reported on bill 2172 before Congress transfering cable television to Federal regulation instead of local control. L.C.O.G. opposes this legislation and advise all to write their representatives in Congress.

- 4. City Recorder stated that the City sent a letter to Mr. Reiterman on Alder Dr. regarding the encroachment of his home on the right of way. She stated that this letter was sent registered mail.
- 5. There was a letter from L-COG concerning a representative from Dunes City. Mayor Petersdorf instructed the City Recorder to send a letter to L-COG stating that the City would wait to appoint a representative until after the new council takes over in January.
- 6. There was a letter from L-COG stating that they will be holding a conference Monday, November 8.
- 7. There was a letter from Mark Hatfield and Bob Packwood answering the City's letter regarding their feelings on House Bill S-2172, Regulating Cable TV Franchise.

Gerber stated at this time that he has found that the City's date for reviewing the Cable TV Franchise rates is in November, 1983, instead of November, 1982. He felt that the Council should be thinking about what they will be asking for at that time.

Also, Gerber discussed with the Council the Senate's reactions to the house bill.

J. Freeland suggested that the City write another letter to the Senate giving it's objections. This bill has passed the committee but has not yet gone to the floor.

The Mayor instructed the City Recorder to send a letter giving the City's further objections on this bill to Weaver, Hatfield and Packwood.

#### VII. REPORTS

1. Roads. J. Freeland stated that the culverts are all in. He also stated that at the last Road Committee meeting Ira Mann was voted as Road Chairman, again. Freeland also stated that there is a lot of patching being done on City streets. The committee would like to know if they could store some cold mix asphalt out here in the yard of the center. They would build some sort of container to keep it in. The Council had no objection to this. Freeland brought up the fact that the road committee would like to purchase a brush cutter for brushing out the

Dunes City Council 10-14-82 Page 3

streets. There was a question on insurance, however. Would the City be liable if one of these volunteers were out using the machine and was injured. Mr. Gerber stated that the City would be liable. He also stated that he would have to look into the City's insurance to see if the volunteers were covered.

Also, the Council stated that they needed from the road committee a list of the streets and a list of the members of the road committee.

Planning Commission Report. E. Passenger stated that in the minutes of the Planning Commission they discussed the computer map. They found that the map was incorrect as it did not list the Bob Jackson property as commercial.

The Council discussed this and, according to the Comp. Plan, this property is zoned commercial. The computer map is incorrect and will be sent back with the corrections noted.

Legal Council Report. Lemke -- Gerber stated that there was a memo in the packets concerning this and he did not feel that he wanted to discuss this in an open meeting at this time.

Public Hearing. Mayor Petersdorf moved the agenda down to Public Hearings. He stated that there would not be a Public Hearing because Mr. Parker of West Lane Disposal was unable to get his material read in time for the Council to review it. Mr. Gerber stated that the Public Hearing will be held at the next Council meeting. Mr. Parker will have filed by then.

Dave Clark was present to represent Mike Johnson.

Police Commissioner Report. E. Passenger stated that she had gone out on a dog complaint over on Ocean Blvd. She said that no one was home , but she found that there were five (5) hunting dogs on the property and four (4) puppies. She felt that it was not only a nuisance but a health hazard. There was an odor and a lot of flies.

Council discussed this and found that the Zoning Ordinance, page 71, defines a "KENNEL" as any lot on which three or more dogs over the age of four months are kept. A Kennel is a Home Occupation so this would require a Conditional Use Permit.

Council discussed this further and decided that proceedings for abating the nuisance would begin. They felt that the letter should come from Mr. Gerber's office, but it would be hand delivered by the Police Commissioner, E. Passenger.

Neighborhood Watch Report. E. Passenger and B. Pitts gave a brief report on the happenings with the Dunes City Chapter of Neighborhood Watch. B. Pitts was elected interim President for 90 days, E. Passenger the secretary, E. Fillman the Vice-President and B. Smith the Treasurer.

They stated that they have filed their papers for incorporation and have applied for a group radio license. They are working on their by-laws.

They requested of the City that, since the City does have a budget for Police Protection but does not have police protection, possibly some of the money could go to the Neighborhood Watch. They were asking for \$1000 of that budgeted money.

- E. Passenger gave a list of costs for the signs needed in the City. The cost for the signs would run about \$336. Council discussed the fact that maybe they should wait until the Neighborhood Watch completed all of their paper work before the money was allotted.
- J. Freeland moved that the City grant \$500 to the Dunes City Chapter of Neighborhood Watch so that they may order the signs and that the second \$500 be allotted after the paperwork is finished. Petersdorf seconded and the motion carried.

Siuslaw Forum. E. Fillman gave a brief report on the happenings with this committee. The Council had in their packets the by-laws of the forum. E. Fillman stated that he felt that the City should pay the \$200 annual membership fee to this group. He had put in a lot of time for this group and felt that at least it is helping all of these different bodies work together instead of against one another.

J. Freeland moved that the \$200 fee to the Greater Siuslaw Economic Forum be paid. Passenger seconded and the motion carried.

Fire Protection. Mr. Libby did not show up.

Committee for Hiring Planning Commission Secretary. Mayor Petersdorf stated that the committee 's four members met on the evening of Oct. 13 and interviewed five (5) applicants for the position. The committee was made up of E. Passenger, J. Smith, D. Stinger and the Mayor. Their recommendation to the City Council was Mrs. Kay Bacon for the position. Mrs. Bacon was in the audience.

ACTION

E. Fillman moved that the City Council accept the recommendation of the committee and hire Kay Bacon for the position of Planning Commission Secretary. J. Freeland seconded and the motion carried.

Mayor Petersdorf stated that the salary would start at \$3.50 per hour and then will be reviewed in three (3) months.

#### IX. UNFINISHED BUSINESS

Woahink Mobile Home Resort. Council discussed the fact that lots of work is going on over there. They are making an effort to comply.

#### NOVEMBER 11, 1982

#### I. CALL TO OREDER AND ROLL CALL

The regular meeting of the Dunes City Council was called to order by Mayor Petersdorf on the 11th day of November, 1982, at 7:30 p.m.

ROLL CALL

#### II. APPROVAL OF MINUTES

Correction on Pg. 5 Building Code Ord. #77. E. Passenger asked that the minutes show that there had been no discussion of this ordinance in the September meeting because it had been tabled until the October meeting.

Correction on Pg. 7 there was a typographical error in the word "Cable" in the Cable TV Review heading.

III. BILLS AGAINST THE CITY -- \$1, 057.82

ACTION Motion was made

Motion was made by E. Passenger and seconded by J. Freeland to pay the bills against the city. Motion carried.

IV. RECEIPTS OF THE SESSION -- \$3,466.07

E. Passenger noted that the council had previously agreed to pay 50% of the Room Tax (which totaled \$1,169.46 for this session) to the Chamber of Commerce for advertising. Mayor Petersdorf said the City is holding off paying this because "the Chamber has been leaving the City out of their activities".

#### X. NEW BUSINESS

The Mayor moved the Agenda down to New Business to take care of the West Lane Disposal ordinance so that Mr. Hilborn could be excused. J. Hilborn presented the proposed short and long titles of Ordinance #51 as proposed by West Lane Disposal. He stated that this was the beginning of the initiative petition process.

"AN ORDINANCE CREATING MULTI-LICENSEES INSTEAD OF EXCLUSIVE REFUSE FRANCHISE."

"THE ORDINANCE BEFORE THE CITY CHANGES THE EXISTING METHOD OF REGULATING REFUSE AND GARBAGE PICK-UP. PRESENTLY, THE CITY IS ALLOWED TO ENTER INTO AN EXCLUSIVE FRANCHISE WITH ONE REFUSE COLLECTION SERVICE. THE PROPOSED ORDINANCE ALLOWS MULTIPLE LICENSEES TO ENGAGE IN THIS BUSINESS. THE PROPOSED ORDINANCE REQUIRES THE CITY TO LICENSE, KEEP RECORDS AND INSPECT REFUSE VEHICLES. LICENSEES MUST PAY A YEARLY FEE AND PROVE INSURANCE. FEES ARE SET BY THE LICENSEE OR CITY COUNCIL."

J. Hilborn explained that it is his understanding that the proposed ordinance would not affect any existing contracts until their normal termination, but it does away with the Council's authority to grant exclusive franchises if it is approved by the public.

Mike Johson, representing Siuslaw Sanitary Service, read a letter to those present and gave copies of the letter to the council members.

B. Stocking read a letter to the Council that had come into the office from Mr. Loren Parker of West Lane Disposal. Mr. Parker came into the meeting in the middle, and J. Hilborn recapped for him what had been done.

David Clark, Attorney at Law, representing Siuslaw Sanitary Service, stated he felt the ballot title should reflect that the ordinance would not affect the current franchise until its conclusion and merely replaced Ordinance #38.

J. Hilborn will discuss with B. Stocking what she needs to do now about Mr. Parker's petition.

- R. Gerber stressed that if the City did not pass the ordinance, the state would take over administering the state building codes; and he felt that it was to the City's advantage to supervise the code itself.
- 3. Seaplane Ordinance #78
  Before the Council heard public testimony on this ordinance,
  R. Gerber explained why the ordinance was drafted; i.e., to
  restrict intense development around the lake's edge and to
  discourage the use by seaplanes of the lake.
- Mr. Joseph Holden, Assistant Administrator in charge of Air Operations and Safety from the Aeronautics Division of the State Department of Transportation presented a lengthy opinion prepared by his office and consulted with the State Attorney General's office. In his presentation he indicated that the proposed city ordinance would be in violation of existing state law. A copy of his remarks are included with the packet.

Mr. Dave Wiley of the Columbia Seaplane Pilot's Association was at the meeting. He wanted to object to being considered a public nuisance and asked for clarification of how a seaplane is a public nuisance. He argued that seaplanes are highly maneuverable and have a high safety record throughout the nation.

Butch Patterson from the Seaplane Rides was concerned that the ordinance would affect the operation and expansion of his business.

#### ACTION

Motion was made by E. Passenger and seconded by J. Freeland to table the ordinance until the next meeting to give Attorney Gerber time to research the information presented by Mr. Holden. Motion carried.

- 4. Dog Complaint. E. Passenger delivered the letter to Mr. Anderson about the number of dogs he was keeping on his property. She found that he is in the process of moving out of the area.
- 5. Ternyik Planting on Lemke Property. Wilbur Ternyik is scheduled to start planting on November 15th on the Lemke property. The Council agreed that they would take action if he failed to start by the 15th.
- 6. Woahink Mobile Home Park. R. Gerber and Mayor Petersdorf stopped and talked to the contractor about a week before the meeting. They said the work seems to be moving right along there. Mayor Petersdorf said he would like the council to be thinking before next month's council meeting about getting back from Woahink Mobile Home Park the considerable amount of money the City has spent on attorney's fees for this matter.

#### VIII. EXECUTIVE SESSION

He suggested the most sensible way the City could approach the problem is in terms of making it a zoning law. It would necessitate redrafting the ordinance. Gerber felt it would be best to meet with the Council next month after the new members have been seated and decide if they still want to continue with an ordinance. If so, he would have an ordinance ready for the first reading at the February meeting.

Gerber said he had received a letter from the Army Corps of Engineers saying that Woahink Lake is not a navigable waterway.

- 2. Re-Seeding Lemke Property. Mrs. Barbara Garrison said that she had visited the property, and the work had been done. She was satisfied.
- 3. Road at Little Woahink. Mr. Gerber said this problem should be carried over to the January meeting so that he could discuss this with the new council members, too.

He had noticed that many of them were in need of repair. He was told that if money is given to individuals to build them it comes from the road committee's budget.

## EXECUTIVE SESSION December 9, 1982

The Executive Session began at 8:03 p.m. on the Alice Thompson project.

Attorney Jim Hilborn announced that he had advised both Thompson and Larry Gildais, her attorney, that the Council would be discussing this item, but neither was present.

Mayor Petersdorf told Hilborn that the City would like to get back from Alice Thompson the amount of the attorney fees and the office time spent on the nuisance abatement for Woahink Mobile Home Resort.

Hilborn said that under Section #5 of Ordinance #51 the City may recover all the costs of an abatement of a nuisance plus 15% of administrative costs. Section #7 of Ordinance #51 gives the Council authority to fine \$500 a day for each day they are in violation.

Hilborn suggested that if the Council decided to fine Thompson, they would have to fine her specific amounts for specific days that Thompson was in violation.

E. Passenger suggested she would like to see the Council assess Thompson for attorney fees plus 15% of administrative costs rather than fine her \$500 per day. J. Freeland did not want to assess punitive damages.

Hilborn advised the Council to direct Thompson and her attorneys by certified mail that the City was assessing costs. After she is notified, she has ten (10) days to object. Then she can be put on the City Council agenda to rebut. A lien will be issued against her property in 30 days if she does not object within ten (10) days.

## MINUTES OF THE CITY COUNCIL EMERGENCY SESSION

#### DECEMBER 23, 1982

#### I. ROLL CALL

The emergency session of the Dunes City Council was called to order at 2 p.m. by Mayor Petersdorf.

Present: J. Baumeister, R. Schmale, E. Passenger and B.

Petersdorf.

Absent: W. Pitts, J. Freeland and E. Fillman. Mr. Fillman

was excused.

Attorney R. Gerber was also present.

The secretary was instructed that in case of a tie vote (constituted by three members voting in unison) the Mayor could vote to break the tie.

#### II. NEW BUSINESS

Attorney Gerber brought the Council up to date on why the Mayor had called for a special session to consider the offer to settle made by Don Lemke with regard to the lien the City had assessed against him.

The Mayor had polled the Council earlier when it was learned Mr. Lemke wanted to settle. The consensus was that the Council would consider settling for \$5670.76. Mr. Gerber had relayed the information to Mr. Cooley, Lemke's attorney; and had told him the Council would not consider settling as long as their lawsuit against the City was pending.

R. Schmale disclosed a potential conflict of interest. Mr. Gerber said that his potential conflict of interest would not disqualify him unless he felt he could not approach the matter with an open mind.

Mr. Gerber announced that paying the lien would be a disbursement out of escrow. When the sale of the property closes, the escrow company will issue a check to Dunes City for the sum of \$5,670.76. The City will not accept that check, Mr. Gerber said, until we have in hand a stipulation signed by Mr. Lemke's lawyer to the effect that the lawsuit should be dismissed.

J. Baumeister requested that the City not accept the check until the courts dismiss the case.

Secretary K. Bacon told the Council that the Dunes City office had received a lien search on the property in question and asked how the office should handle it. Mr. Gerber said that the stipulated order should arrive at the escrow office that afternoon (December 23). Mr. Gerber was going to go to the office and review it to make sure it was in the proper order and instruct Mr. Lemke to have it signed by a judge December 24. He would tell Lemke that the City will not release a clear lien search until it is done. Then Mr. Gerber's office will release the lien search.

E. Passenger made the motion which was seconded by J. Baumeister to adopt resolution 12-23-82. All three council members voted in favor. The mayor also voted in favor. Motion carried. A copy of the resolution is attached.
