# 1. CALL TO ORDER

Budget Officer Jamie Mills called the Wednesday, November 18, 2020 meeting of the Dunes City Budget Committee to order at 5:35 pm on the behalf of Mayor Robert Forsythe, who was experiencing remote meeting audio difficulties.

# 3. PLEDGE OF ALLEGIANCE

Budget Officer Jamie Mills led a reciting of the Pledge of Allegiance on the behalf of Mayor Forsythe.

#### 4. APPROVAL OF THE AGENDA

Councilor Snow made a motion to approve the agenda. Citizen Member Hammond seconded the motion. The motion passed by unanimous vote.

## 5. APPROVAL OF THE MEETING MINUTES FOR DECEMBER 11, 2019

Councilor Snow made a motion to approve the minutes of the December 11, 2019 meeting. Citizen Member Hammond seconded the motion. The motion passed by unanimous vote.

# 6. REVIEW OF FIRST TWO QUARTERS OF FY 20-21 BUDGET VS. ACTUAL

Councilor Snow noted with approximately 4 ½ months into the year, the percent of budget for the year to date is around 35%.

Mills stated the City received a \$100,000.00 grant from the Oregon Department of Transportation for road maintenance on Parkway Drive. Mills also stated the City has been invited to apply for a grant for Rebecca's Trail.

Citizen Member Snow indicated there were no major expenses that were out of line.

Mills said there was a decrease in the Cigarette Tax Revenue, no change in the Gas Tax Revenue, and an increase in the Alcohol Tax Revenue.

Mills explained expenses relating to personnel, there was an increase in Worker's Compensation Insurance and PERS was at 15.9%.

## 7. UPDATE OF POSSIBLE NEED TO ADOPT SUPPLEMENTAL BUDGET

Mills said there may be a need for a Supplemental Budget if the City receives a grant for Rebecca's Trail.

## 8. Public Comment and Questions

Citizen Stacy Adleson asked Budget Officer Mills if she felt there was anything out of place relating to the budget. Mills stated there were no concerns and the budget was normal for this time of year.

## 9. FOR THE GOOD OF THE ORDER

Councilor Wells questioned if there was a better system for future remote meetings.

## 10. ADJOURNMENT

Council President Meyer made a motion to adjourn. Councilor Wells seconded the motion. The motion passed by unanimous vote.
