A. Review Citizen Input Q2, 2021

C. Review Outdoor Lighting Draft Ordinance

Commissioners reviewed the changes and suggested the following additional changes:

- 1. Add the phrase "reflection off the lake" to the **TITLE AND PURPOSE** section.
- 2. Add the term "boat house" to the **SCOPE AND APPLICABILITY** section.
- 3. Delete the last sentence in paragraph **B** of the **SCOPE AND APPLICABILITY** section.
- 4. Delete "Type I, Type II, Type III" from paragraphs **A** and **B** of the **LIGHTING PLAN REQUIRED** section.
- 5. Combine some of the terms in paragraphs A H of the **PROHIBITED LIGHTING** section.
- 6. Administrative Assistant Oberholtzer stated that City Administrator/Recorder Mills will ask the City attorney about the legality of the wording in paragraph **H** of the **PROHIBITED LIGHTING** section.

Vice Chair Pesnell made a motion for Staff to edit the Ordinance, and then submit it to the City attorney for review and presentation to the City Council.

Commissioner Phillips seconded the motion and it passed by unanimous vote.

Chair Allen stated that if the City attorney makes major changes, the Planning Commission wants to review the Draft Ordinance again.

The DLCD Post Acknowledgement Plan Amendments handout was reviewed.

- 2. Dunes City's current code states 45 days but the revised code will state 35 days.
