Individuals who receive their water from Woahink Lake by relying on the City's water right permit (the Dunes City Shared Domestic Water Supply Program) must have their meters replaced with radio read meters and approved fish screens installed with information regarding pumps, gallons per minute, horsepower and pipe size to Dunes City before October 1, 2022. Your plumber can also provide you with the information the City must report to the State (pump size, GPM, hp, etc) and must be reminded to take a photo of the fish screen installed on the pump before returning the pump into the water and to email the photo to the property owner and the City.
